

## ORDINANCE NO. 1034

AN ORDINANCE OF THE CITY OF COLLINSVILLE, OKLAHOMA (THE "CITY"), AMENDING ORDINANCE NO. 684, AS AMENDED BY ORDINANCE NO. 826 OF THE CITY, BY ELIMINATING THE TERMINATION DATE FOR THE COLLECTION OF THE EXCISE TAX (SALES TAX) LEVIED PURSUANT TO SAID ORDINANCES; PROVIDING FOR THE EFFECTIVE DATE; PROVIDING REMAINDER OF ORDINANCES REMAIN UNCHANGED; PROVIDING THAT THE PROVISIONS OF THIS ORDINANCE ARE CUMULATIVE AND IN ADDITION TO ANY AND ALL TAXING PROVISIONS OF OTHER CITY ORDINANCES; PROVIDING FOR SEVERABILITY OF PROVISIONS; AND CONTAINING OTHER PROVISIONS RELATED THERETO.

WHEREAS, the City adopted Ordinance No. 684 on March 17, 1999 ("Ordinance No. 684"), which Ordinance levied a one percent (1.0%) excise tax (sales tax), with said tax being levied for the purpose of providing revenues to be used for capital expenditures, including but not by way of limitation, improvements to the electric, water and sanitary sewer systems of the City of Collinsville, Oklahoma, for the use and benefit of the City and any public trust having the City as its beneficiary thereof and/or for the payment of debt service in connection with obligations issued to finance said capital expenditures, all as more specifically set forth in Ordinance No. 684, and with said one percent (1.0%) tax terminating September 30, 2019; and

WHEREAS, the City adopted Ordinance No. 826 on January 5, 2009 ("Ordinance No. 826"), amending Ordinance No. 684 by increasing the amount of sales tax levied to one and three-quarters of one percent (1.75%) excise tax (sales tax), extending the termination date to June 30, 2029, and modifying the purpose to be used for the making of capital improvements of the City of Collinsville, Oklahoma, and payment of the principal of and interest on indebtedness to be incurred on behalf of said City by any public trust having the City as beneficiary thereof for providing capital improvements of said City; and

WHEREAS, Ordinance No. 684, as amended by Ordinance No. 826 shall be referred to collectively herein as the "Ordinance"; and

WHEREAS, the one and three quarters of one percent (1.75%) excise tax (sales tax) levied pursuant to the Ordinance shall be referred to herein as the "excise tax (sales tax)" or the "tax"; and

WHEREAS, the City desires to eliminate the termination date with respect to the collection of said excise tax (sales tax) levied pursuant to the Ordinance.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF COLLINSVILLE, OKLAHOMA, AS FOLLOWS:

Section 1. Amendment to Section 4 of Ordinance No. 684, as amended by Ordinance No. 826.

Section 4 of Ordinance No. 684, as amended Ordinance No. 826 is amended to read as follows:

“Section 4. Effective Date; Termination Date. This Ordinance shall become and be effective on and after July 1, 2009, and only upon approval of a majority of the qualified electors of the City of Collinsville, Oklahoma, voting on the proposition of approving the same in the manner prescribed by law. This Ordinance and the excise tax (sales tax) levied pursuant to this Ordinance shall have no stated termination date.”

Section 2. Effective Date. The provisions of this Ordinance shall become effective on and after July 1, 2024, subject to approval by a majority of the qualified electors of the City of Collinsville, Oklahoma, voting on the same in the manner prescribed by law.

Section 3. Remainder of Ordinance No. 684, as amended by Ordinance No. 826, Remain Unchanged. Except as amended herein, the remaining provisions of Ordinance No. 684, as amended by Ordinance No. 826 shall remain unchanged.

Section 4. Provisions Cumulative. The provisions hereof shall be cumulative and in addition to any and all other taxing provisions of City Ordinances.

Section 5. Severability. The provisions of this Ordinance are severable, and if any part or provision hereof shall be adjudged invalid by any court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.\
