

## **RESOLUTION NO. 15-32**

**A RESOLUTION AMENDING APPENDIX A, SCHEDULE OF FEES AND CHARGES, LAWTON CITY CODE, 2005, AS AMENDED, BY ADDING A MUNICIPAL COURT TECHNOLOGY FEE AS SET FORTH IN EXHIBIT “A” ATTACHED HERETO, AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Lawton has adopted an ordinance establishing a municipal court technology fee which shall be in addition to and not in substitution for any and all costs, fees, fines or penalties otherwise provided for by law and assessed on every citation disposed of in the municipal court except those that are voided, declined for prosecution, dismissed without costs, or the defendant is acquitted; and

**WHEREAS**, the revenues generated by this fee shall be used solely and exclusively for the acquisition, operation, maintenance, repair and replacement of data processing equipment and software related to the administration of the municipal criminal justice system and the costs of prosecution; and

**WHEREAS**, due to the passage of the aforementioned ordinance, a need exists to amend Appendix A, Chapter A-9, Court Fees, Lawton City Code, 2005, as amended, to include said municipal court technology fee; and

**WHEREAS**, Section 1-2-205, Lawton City Code, 2005, provides that fees and charges be set by resolution.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the City of Lawton, Oklahoma that:

Section 1. APPENDIX A Schedule of Fees and Charges, Lawton City Code, 2005, be as amended as set out in the attached Exhibit A.

Section 2. EFFECTIVE DATE. The provisions of this resolution shall be in full force and effective on the 14th day of May, 2015.
