

**RESOLUTION NO. 16-14**

A RESOLUTION AMENDING ARTICLE A-19-1, CHAPTER A-19, APPENDIX A, SCHEDULE OF FEES AND CHARGES, LAWTON CITY CODE, 2015, BY REDUCING CAMPGROUND RELATED FEES DURING THE OFF SEASON AT LAKES ELLSWORTH AND LAWTONKA AS SET FORTH IN EXHIBIT "A" ATTACHED HERETO, AND ESTABLISHING EFFECTIVE DATE THIRTY (30) DAYS AFTER PASSAGE.

**WHEREAS**, the City of Lawton Parks and Recreation Department and the Lakes and Land Commission has determined that there is a need for continuous usage in lake activity and use of lake facilities during the off season between October 1 and March 1 annually and by providing a reduction in camping fee rates would result in a increase in campground usage during the off season and increase usage year round; and

**WHEREAS**, the City of Lawton Parks and Recreation Department and the Lakes and Land Commission has determined that the reduction in the off season campground related fees at Lakes Ellsworth and Lawtonka is necessary to help offset said increased operational costs; and

**WHEREAS**, Section 1-2-205, Lawton City Code, 2015, provides that fees and charges be set by resolution.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the City of Lawton, Oklahoma that:

Section 1. APPENDIX A, Schedule of Fees and Charges, Lawton City Code, 2015, be amended as set out in the attached Exhibit "A".

Section 2. EFFECTIVE DATE. The provisions of this resolution shall be in full force and effective thirty (30) days after passage.
