

**ORDINANCE 2023-10**

**AN ORDINANCE AMENDING ADDIS CODE OF ORDINANCES, CHAPTER 113: ZONING; ARTICLE IV: SUPPLEMENTAL REGULATIONS; DIVISION 3: HOME OCCUPATIONS; SEC. 113-194 (17) USE LIMITATIONS TO DELETE THE REQUIREMENT OF THE TOWN OF ADDIS AND THE TOWN OF ADDIS PLANNING AND ZONING COMMISSION TO REVIEW AND APPROVE A HOME OCCUPATION PERMIT AFTER FOUR (4) YEARS.**

WHEREAS, the Mayor and Town Council of the Town of Addis are empowered to regulate the issuance and permitting of Home Occupations within the Town of Addis; and

WHEREAS, the Town Council for the Town of Addis is desirous of specifically deleting the requirement presently in force that the Planning and Zoning Commission review and the Town Council approve a Home Occupation Permit after four (4) years; and in furtherance thereof they desire to amend **ADDIS CODE OF ORDINANCES, CHAPTER 113: ZONING; ARTICLE IV: SUPPLEMENTAL REGULATIONS; DIVISION 3: HOME OCCUPATIONS; SEC. 113-194 (17) USE LIMITATIONS TO DELETE THE REQUIREMENT OF THE TOWN OF ADDIS AND THE TOWN OF ADDIS PLANNING AND ZONING COMMISSION TO REVIEW A HOME OCCUPATION PERMIT AFTER FOUR (4) YEARS.**

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and the Town Council of the Town of Addis, Louisiana acting as the governing authority thereof, that they do hereby amend **ADDIS CODE OF ORDINANCES, CHAPTER 113: ZONING; ARTICLE IV: SUPPLEMENTAL REGULATIONS; DIVISION 3: HOME OCCUPATIONS; SEC. 113-194 (17) USE LIMITATIONS** by deleting the last sentence and to read as follows:

*“(17) All home occupation permits shall be valid for a period of one year and shall be renewed by the permittee each year.”*

**BE IT FURTHER ORDAINED** by the Town Council of the Town of Addis, Louisiana that any provisions or items of this Ordinance or the application thereof if held invalid, such invalidity shall not affect other provisions, items, or applications, and to this end, the provisions of this Ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED**, by the Mayor and the Town Council of the Town of Addis, Louisiana, acting as the governing authority thereof, that this Ordinance shall be designated as Ordinance 2024-10.

THIS ORDINANCE HAVING BEEN INTRODUCED at a Regular Meeting of the Mayor and Town Council on the 12<sup>th</sup> day of December, 2023, and having been read paragraph by paragraph at a Regular Meeting of the Mayor and Town Council of the Town of Addis, Louisiana, duly convened on the 7<sup>th</sup> day of February, 2024, said Ordinance was,
