ORDINANCE NO. 1075

AN ORDINANCE AMENDING CHAPTER 15.04 OF THE HOBBS MUNICIPAL CODE REGARDING BUILDING CODE ADOPTION AND GENERAL PROVISIONS

WHEREAS, the State of New Mexico Construction Industries Commission adopts the Uniform Mechanical Code and Uniform Plumbing Code, and amends as necessary in the New Mexico Administrative Code; and

WHEREAS, the City of Hobbs wishes to provide consistency by adopting the State of New Mexico Construction Industries Commission's regulations as they are printed in the New Mexico Administrative Code.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HOBBS, NEW MEXICO that Chapter 15.04 of the Hobbs

Municipal Code is hereby amended to read as follows:

15.04.010 Building Codes

Articles 14.7.2 and 14.7.3 of the New Mexico Administrative Code, as amended from time to time, commonly cited as the Commercial Building Code and the Residential Building Code which encompasses the International Building Code, are hereby adopted as the City's Building Codes. A copy of the Articles shall be available for inspection at the office of the City Clerk during the normal and regular business hours of the City Clerk.

Article 14.10.4 of the New Mexico Administrative Code, as amended from time to time, commonly cited as the New Mexico Electrical Code and National Electrical Code, are hereby adopted as the City's Building Code. A copy of the article shall be available for inspection at the office of the City Clerk during the normal and regular business hours of the City Clerk.

Articles 14.8.2, 14.9.2, 14.9.6 and 14.8.3 of the New Mexico Administrative Code, as amended from time to time, commonly cited as the New Mexico Plumbing Code, New Mexico Mechanical Code, New Mexico Solar Energy Code and New Mexico Swimming Pool, Spa, and Hot Tub Code are hereby adopted as the City's Plumbing and Mechanical Codes.
