**Whereas,** The Specific persons now authorized by this resolution to sign and manage all accounts will be Steven L. Brannon, Mayor, Haley Black, City Clerk and, Jerry A. Mauldin, Mayor pro-Tem.


**Whereas,** The City Council hereby authorizes Steven L. Brannon, Haley Black, and Jerry A. Mauldin full authority to initiate any and all transaction required by the Banks to make transactions; and

**Whereas,** The City Council further desires to make this transition post haste, the public welfare and best interest demanding; and

**Therefore,** with an affirmative and majority vote of the City Council on this July 12, 2022, this resolution will be binding and effective immediately.

This resolution was adopted by a vote of 4 affirmative and 0 no (nay) by the Fairmount City Council and recorded in the office of City Clerk on 07/12, 2022.

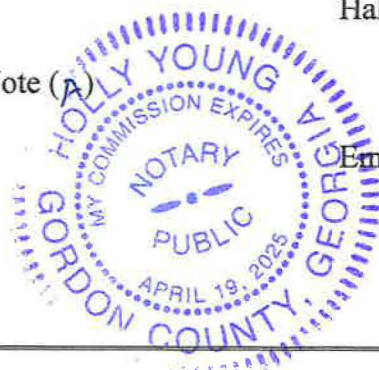
