

ORDINANCE NO. 322

AN ORDINANCE repealing Ordinances Nos. 154 and 279 of the Town of College Place and adopting, by reference, the Western Plumbing Officials Uniform Plumbing Code, 1967 Edition, with certain amendments to said Uniform Code, together with an amendment of Section 1.12 of the Uniform Plumbing Code making provision for a revised fee schedule; and providing for the effective date of this ordinance.

BE IT ORDAINED by the Town Council of the Town of College Place, Washington:

Section 1. That Ordinances Nos. 154 and 279 of the Town of College Place shall be and the same are hereby repealed; the date of the repeal to be simultaneously with the commencement of the effective date of the Uniform Plumbing Code hereinafter provided for.

Section 2. That the Western Plumbing Officials' Uniform Plumbing Code, 1967 Edition, is hereby adopted by reference as the Plumbing Code of the Town of College Place, Washington, with the exception of certain specific ordinances hereinafter provided for. That three copies of said Western Plumbing Officials' Uniform Plumbing Code, 1967 Edition, have heretofore been filed with the Town Clerk of the Town of College Place and said Plumbing Code is made a part of this ordinance as though fully set forth at this place and in accordance with the terms and conditions of Section 35.21.180 of the Revised Code of Washington Annotated.

Section 3. That Section 1.12 of Part I of the Uniform Plumbing Code shall be amended to read as follows:

"Section 1.12 -- Plumbing Permits - Fees. Every applicant for a permit to install, add to, alter, relocate or replace a plumbing or drainage system or part thereof, shall state in writing on the application form provided for that purpose, the character of work proposed to be done and the amount and kind in connection therewith, together with such information pertinent thereto as may be required.

Such applicant shall pay for each permit issued at the time of issuance, a fee in accordance with the following schedule, and at the rate provided for each classification shown therein.

Any person who shall commence any plumbing work for which a permit is required by this code without first having obtained a permit therefor shall, if subsequently permitted to obtain a permit, pay double the permit fee fixed by this section for such work, provided, however,

that this provision shall not apply to emergency work when it shall be proved to the satisfaction of the Administrative Authority that such work was urgently necessary and that it was not practical to obtain a permit therefor before the commencement of the work. In all such cases a permit must be obtained as soon as it is practical to do so, and if there be an unreasonable delay in obtaining such permit, a double fee as herein provided shall be charged.

For the purpose of this section a sanitary plumbing outlet on or to which a plumbing fixture or appliance may be set or attached shall be construed to be a fixture. Fees for reconnection and retest of existing plumbing systems in relocated buildings shall be based on the number of plumbing fixtures, gas systems, water heaters, etc., involved.

When interceptor traps or house trailer site traps are installed at the same time as a building sewer on any lot, no sewer permit shall be required for the connection of any such trap to an appropriate inlet fitting provided in the building sewer by the permittee constructing such sewer.

When a permit has been obtained to connect an existing building or existing work to the public sewer, backfilling of private sewage disposal facilities abandoned consequent to such connection is included in the building sewer permit."

Section 4. That the following schedule of fees shall be charged and collected:

For issuing each permit	\$2.00
In addition -	
For each plumbing fixture or trap or set of fixtures on one trap (including water, drainage piping and backflow protection therefor)	1.50
For each building sewer and each trailer park sewer	5.00
Rainwater systems - per drain	2.00
For each water heater and/or vent	1.50
For each industrial waste pre-treatment interceptor, including its trap and vent, excepting kitchen type grease interceptors functioning as fixture traps	1.00
For installation, alteration or repair of water piping and/or water treating equipment	1.50
For repair or alteration of drainage or vent piping	1.50
For each lawn sprinkler system on any one meter including backflow protection devices therefor	2.00
For vacuum breakers or backflow protective devices on tanks, vats, etc. or for installation on unprotected plumbing fixtures including necessary water piping - one (1) to five (5)	2.00
Over five (5), each	.30

Section 5. That all of Chapter 12 and all of Chapter 13 of the Uniform Plumbing Code hereinbefore referred to shall be deleted and shall not be adopted and incorporated in this ordinance. That all references to gas piping and venting in said Uniform Plumbing Code are hereby omitted.

Section 6. That Chapter 2 of said Uniform Plumbing Code, under the appendix or addition thereto described as Table A, relative to plumbing material standards, shall also be deemed and construed to include the following specifications and requirements relative to particular types of plastic pipe to which reference is not made in said Table A. The following material may be used for both drain, waste and vent inside and outside of building and pressure pipe outside of building only:

PVC DWV (Type 1, Grade 1, design stress 2000 p.s.i.)
ABS DWV 1316 (Type 1, Grade 3, recommended stress 1600 p.s.i.)
PE DWV 3306 (Type 3, Grade 3, 630 p.s.i.)

PVC, ABS and PE plastic pipe can be used for transmission of cold water outside of a building, or for underground sprinkler systems.

All plastic pipe shall have the code printed along the pipe at regular intervals.

When plastic pipe as specified in code is used all permits will bear description of the material used.

Plastic pipe not to be used on multistory buildings.
Plastic pipe not to be used under concrete slabs.
Plastic pipe not to extend beyond property line.

Section 7. That the Western Plumbing Officials Association Installation Standard, Issue May, 1965, for ABS Drain, Waste and Vent Pipe and Fittings is hereby adopted by reference by the Town of College Place, Washington. That three copies of said Installation Standards for ABS Drain, Waste and Vent Pipe and Fittings have been filed with the Town Clerk of the Town of College Place and is made a part and parcel of this ordinance as though fully set forth at this place and in accordance with the terms and conditions of Section 35.21.180 of the Revised Code of Washington Annotated.

Section 8. This ordinance shall become effective immediately upon its passage, adoption and posting as required by law.
