

ORDINANCE NO. 1685

AN ORDINANCE OF THE CITY OF FAIRWAY, KANSAS, AMENDING AND REPEALING SECTION 2-228 AND 2-229 REGARDING THE POLICE DEPARTMENT OF THE FAIRWAY MUNICIPAL CODE AND ADDING NEW SECTIONS 2-290 AND 2-291 REGARDING PUBLIC WORKS DEPARTMENT AND SECTIONS 2-300 AND 2-301 REGARDING PARK AND RECREATION DEPARTMENT.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FAIRWAY, KANSAS:

SECTION 1. Existing Section 2-228 entitled "Composition" of the Codified Ordinances of the City of Fairway Kansas be amended to read as follows:

SEC. 2-228. The Police Department of the City shall consist of the Chief of Police and such number of regular police officers and civilian staff as shall be approved by the Police Committee and provided for in the City budget.

SECTION 2. Existing Section 2-228 of the Code of the City of Fairway, Kansas, is hereby repealed.

SECTION 3. Existing Section 2-229 entitled "Rules and Regulations" of the Codified Ordinances of the City of Fairway Kansas be amended to read as follows:

Sec. 2-229. – Duties of the Chief of Police.

The Chief of Police shall have supervisory responsibility for the operation of the Department including the power to make such rules and regulations as may be necessary for the proper and efficient conduct of law enforcement within the City. The Chief of Police shall perform such duties and functions as are assigned elsewhere in the Code.

SECTION 4. Existing Section 2-229 of the Code of the City of Fairway, Kansas, is hereby repealed.

SECTION 5. That a new Division 3 – entitled "Public Works Department" and new Section 2-290 entitled "Composition" and new Section 2-291 entitled "Duties of the Director of Public Works" of the Code of the City of Fairway is hereby added to read as follows:

DIVISION 3 – PUBLIC WORKS DEPARTMENT

SEC. 2-290. – Composition.

The Public Works Department shall consist of the Director of Public Works and such additional staff as shall be approved by the Public Works Committee and provided for in the City budget.

SEC. 2-291. – Duties of the Director of Public Works.

The Director of Public Works shall have supervisory responsibility for the operation of the Public Works Department including the power to establish such policies and procedures as are necessary and appropriate for the efficient operation of the Department. The Director of Public Works shall perform such duties and functions as are assigned elsewhere in the Code

SECTION 6. That a new Division 4 – entitled "Parks and Recreation Department" Section 2-300 entitled "Composition" and 2-301 entitled "Duties of the Director of Parks and Recreation" of the Code of the City of Fairway is hereby added to read as follows:

DIVISION 4 – PARKS AND RECREATION DEPARTMENT

SEC. 2-300. – Composition.

The Parks and Recreation Department shall consist of the Parks and Recreation Director and such additional staff as shall be approved by the Parks & Recreation Committee and provided for in the City budget.

SEC. 2-301. – Duties of the Parks and Recreation Director.

The Parks and Recreation Director shall have supervisory responsibility for the operation of the Parks and Recreation Department including the power to establish such policies and procedures as are necessary and appropriate for the efficient operation of the Department. The Director of Parks & Recreation shall perform such duties and functions as are assigned elsewhere in the Code.

SECTION 7. That if any portion or section of this Article is determined to be invalid, illegal or unconstitutional by a court of competent jurisdiction, the decision shall in no manner affect the remaining portions or sections of this Article, which shall remain in full force and effect.

SECTION 8. That this Ordinance shall become effective upon adoption and publication of its summary in the official City newspaper.
