

AN ORDINANCE/RESOLUTION  
CITY OF TEMPLE, CARROLL COUNTY, GEORGIA

Pursuant to Georgia Code 40, Article 9, Section 40-6-183, of the Uniform Rules of the Road Act, for Local Authorities to alter lawful speed limits, following is an ordinance regulating speed limits within the City of Temple, Carroll County Georgia.

Be it ordained by the City Council of the City of Temple, Carroll County, Georgia that the following speed zones are established.

ON-SYSTEM

SR-8 (US 78) from the West City Limits, Haralson County Line, (M.P. 0.00) to Lakeview Drive (M.P. 0.38), a distance of 0.38 miles to be zoned for 50 mph.

SR-8 (US 78) from Lakeview Drive (M.P. 0.38) to a point 1500' west of SR-274, James Street, (M.P. 0.61), a distance of 0.23 miles to be zoned for 45 mph.

SR-8 (US 78) from a point 1500' west of SR-274, James Street, (M.P. 0.61) to a point 500' east of SR-274, Sage Street, (M.P. 1.72), a distance of 1.11 miles to be zoned for 40 mph.

SR-8 (US 78) from a point 500' east of SR-274, Sage Street, (M.P. 1.72) to the East City Limits (M.P. 2.30), a distance of 0.58 miles to be zoned for 50 mph.

SR-113 from the South City Limits (M.P. 9.16) to Bud Street (M.P. 10.11), a distance of 0.95 miles to be zoned for 45 mph.

SR-113 from Bud Street (M.P. 10.11) to Milner Street (M.P. 11.18), a distance of 1.07 miles to be zoned for 35 mph.

SR-113 from Milner Street (M.P. 11.18) to the North City Limits (M.P. 12.22), a distance of 1.04 miles to be zoned for 45 mph.

SR-274 from SR-8 (M.P. 0.00) to a point 300' south of Griffin Street (M.P. 0.21), a distance of 0.21 miles to be zoned for 40 mph.

SR-274 from a point 300' south of Griffin Street (M.P. 0.21) to a point 300' east of Johnston Street (M.P. 0.48), a distance of 0.27 miles to be zoned for 35 mph.

SR-274 from a point 300' east of Johnston Street (M.P. 0.48) to SR-8 (M.P. 1.16), a distance of 0.68 miles to be zoned for 40 mph.

SR-274 (School Zone) from a point 1875' north of SR-8 (M.P. 0.80) to a point 475' north of SR-8 (M.P. 1.07), a distance of 0.27 miles to be zoned for 30 mph from 7:30 to 8:30 A.M. and from 2:45 to 4:00 P.M. on "School Days Only".

Signs to be erected by Georgia Department of Transportation.

#### OFF-SYSTEM

Centerpoint Road from SR-8 to city limits, a distance of 1.27 mile to be zoned for 45 mph.

Double D Road from SR-113 to Villa Rosa Road, a distance of 0.79 miles to be zoned for 35 mph.

East Johnson Street from SR-113 to city limits, a distance of 1.17 miles to be zoned for 35 mph.

Lakeview Drive from Old Bremen Road to SR-8, a distance of 0.71 miles to be zoned for 35 mph.

Old Bremen Road from Sage Street to end of pavement, a distance of 1.05 miles to be zoned for 35 mph.

Rainey Road from SR-113 to city limits, a distance of 1.38 miles to be zoned for 35 mph.

Rome Street from Rainey Road to SR-113, a distance of 0.75 miles to be zoned for 30 mph.

Sage Street from SR-274 to SR-113, a distance of 0.55 miles to be zoned for 35 mph.

Venable Road from Centerpoint Road to city limits, a distance of 0.68 miles to be zoned for 35 mph.

Signs to be erected by City of Temple.

Be it resolved that any person convicted of a violation of this ordinance shall be punished as provided for by law.

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

This ordinance shall become effective when appropriate signs are erected.
