

**AN ORDINANCE OF THE CITY OF BELTON AMENDING CHAPTER 4, ANIMALS, ARTICLE IV, LIVESTOCK AND POULTRY, SECTION 4-197, KEEPING POULTRY, OF THE CODE OF ORDINANCES OF THE CITY OF BELTON, MISSOURI.**


**WHEREAS**, from time to time, the Code of Ordinances may be amended, supplemented, modified, or repealed by the City Council.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELTON, MISSOURI, AS FOLLOWS:**


- Section 1.** That Chapter 4, Animals, Article IV, Livestock and Poultry, Sections 4-197 of the Code of Ordinances, City of Belton, Missouri, are hereby amended with additions shown in underlined notation and deletions shown in ~~strike-through~~ notation as detailed and attached in **Exhibit A** incorporated hereto as if fully set forth herein.
- Section 2.** That all ordinances or parts of ordinances in conflict with the provisions hereof are hereby repealed.
- Section 3.** That this Ordinance shall be in full force and effect from and after the date of its passage and approval.



#### **Sec. 4-197. Keeping poultry.**

It shall be unlawful, and it is hereby declared a public nuisance for any person in charge of a residence to keep, harbor or maintain or allow to be kept no more than four-ten poultry animals-hens per acre or part of an acre at such residence unless the residence is licensed as a commercial animal establishment with proper zoning classification therefor. It shall be unlawful, and is hereby declared a public nuisance for any person in charge of a residence to keep, harbor or maintain or allow to be kept any poultry rooster at any residence unless the residence is licensed as a commercial animal establishment with property zoning classification therefor.
