**ORDINANCE NO. 18 - 146**

**AMENDING CHAPTER 20 (DOWNTOWN ADVISORY COMMISSION)  
OF TITLE 2 (BOARDS AND COMMISSIONS) OF THE  
NAPERVILLE MUNICIPAL CODE PERTAINING TO MEMBERSHIP**

**WHEREAS**, the City of Naperville, in its authority as a Home Rule community, has enacted Municipal Code Regulations for the purpose of improving and protecting the public health, safety, comfort, convenience and general welfare of the people; and

**WHEREAS**, Chapter 20 (Downtown Advisory Commission) of Title 2 (Boards and Commissions) establishes the membership composition of the Downtown Advisory Commission; and

**WHEREAS**, the City is seeking an amendment to this Section in order to increase the number of members appointed to the Downtown Advisory Commission.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NAPERVILLE, DUPAGE AND WILL COUNTIES, ILLINOIS**, in exercise of its home rule authority, as follows:

**SECTION 1:** The recitals set forth above are incorporated herein.

**SECTION 2:** Chapter 20 (Downtown Advisory Commission) of Title 2 (Boards and Commissions) of the Naperville Municipal Code is hereby amended by adding the underlined language and deleting the stricken language, as follows:

**2-20-2: - MEMBERSHIP:**

The Commission shall consist of thirteen (13)~~twelve (12)~~ members, appointed by the Mayor with the approval of City Council, pursuant to Section 2-1-2 of this Title, unless otherwise noted. Said membership shall include the following:

1. One member shall be the president of Naperville Area Chamber of Commerce, or his or her designee.

2. One member shall be the executive director of the Downtown Naperville Alliance, or his or her designee.

~~3.~~ One member shall be the president of the Naperville Development Partnership, or his or her designee.

~~4.~~ Two (2) members shall be property owners in the downtown area.

~~5.~~ One member who conducts or manages a business within the central business district.

~~6.~~ Three (3) members shall be citizens appointed at large, whenever possible, at least two (2) of the at-large members shall be reside or own property within the downtown area or within ½ mile of the downtown area.

~~7.~~ One member shall have professional expertise in architecture or design.

~~8.~~ Two (2) City Council members as appointed by the Mayor.

~~9.~~ One member shall be the City Manager or designee.

**SECTION 3:** This Ordinance shall be in full force and effect upon its passage and approval as required by law.
