

#### Background:

The County Attorney's Office, with the assistance of the Municipal Code Corporation (Municode), has been working on consolidating and codifying the County's ordinances and laws, excluding the Land Development Code, into an official County Code. The code, entitled "Hillsborough County Code of Ordinances and Laws, Part A, General Ordinances" is one of two parts. Part B, Public Utilities, was adopted by the Board adoption on November 2, 2011. All obsolete ordinances were brought before the Board for repeal. The remaining ordinances have all been consolidated into this final code. Once Part A is adopted, the County Attorney's Office will issue hardcopies to certain governmental entities and the Municipal Code Corporation will post the code (Parts A and B) online for use by the public. ORDINANCE NO.: 12-26

AN ORDINANCE OF HILLSBOROUGH COUNTY, FLORIDA ADOPTING AND ENACTING THE HILLSBOROUGH COUNTY CODE OF ORDINANCES AND LAWS, PART A, GENERAL ORDINANCES; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

WHEREAS, over the years, Hillsborough County has adopted ordinances necessary for the exercise of its powers as set forth in Chapter 125.01, Florida Statutes; and

WHEREAS, the Municipal Code Corporation has recently organized said ordinances into a codification of ordinances and laws, titled Hillsborough County Code of Ordinances and Laws, Part A, General Ordinances; and

WHEREAS, Part B, Public Utilities, was adopted by the Board of County Commissioners on November 2, 2011.

WHEREAS, Hillsborough County now desires to officially adopt said codified ordinances and laws, creating the Hillsborough County Code of Ordinances and Laws, Part A, General Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HILLSBOROUGH COUNTY, FLORIDA:

#### Section 1.

The Code entitled "Hillsborough County Code of Ordinances and Laws, Part A, General Ordinances," published by the Municipal Code Corporation, consisting of chapters 1 through 52, each inclusive and embracing ordinances deemed advisable to be included that were adopted on or before June 27, 2012, is hereby adopted. A copy of this Code is made a part hereof by reference and is available for public inspection at the Hillsborough County Clerk of the Circuit Court.

#### Section 2.

Ordinances effective after June 27, 2012, that amend or refer to ordinances that have been codified in the Code, when enacted in such form as to indicate an intention to make the same a part of the Code, shall be deemed to be

incorporated in the Code, so that reference to the Code includes these additions and amendments.

#### Section 3.

All Ordinances, enacted prior to June 27, 2012 and not included in the Hillsborough County Code of Ordinances and Laws, Part A, General Ordinances or recognized and continued in force by reference therein, have been previously repealed by Hillsborough County Ordinance Numbers 12-14; 12-15; 12-16; and 12-17.

#### Section 4.

This Ordinance shall become effective upon filing with the Florida Department of State.
