WHEREAS, the Borough has an approved Risk Control Plan for the Camden County Municipal Joint Insurance Fund; and


WHEREAS, the Borough wishes to update said plan to remain in compliance with the Camden County Municipal Joint Insurance Fund; and

EFFECTIVE This article shall take effect upon publication of the ordinance codified herein according to law.




