

ORDINANCE 2-2025

AN ORDINANCE AMENDING CHAPTER 95, ENTITLED "ANIMALS", OF THE CODE OF THE BOROUGH OF MAGNOLIA

WHEREAS, the Borough of Magnolia ("Borough") is a municipal entity organized and existing under the laws of the State of New Jersey and located in Camden County; and

WHEREAS, the Borough seeks to amend Chapter 95 of the Code of the Borough of Magnolia to amend the registration and late fees for the Backyard Chicken Program.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, as follows:

Section 1: Chapter 95 of the Code of the Borough of Magnolia, entitled "Fees", shall be amended to read as follows:

§ 95-27.5 License required; fee; expiration; class

B. Fees


- (1) A license fee of ~~\$10.00~~ \$15.00 shall be paid for each license issued pursuant to this article.
- (2) A late fee for each chicken licensed, if said chicken is not registered by February 28 of the year in question, shall be imposed as follows:
 - (a) An additional fee of \$25.00 for March registration.
 - (b) An additional fee of \$30.00 for April registration.
 - (c) An additional fee of \$35.00 for May registration.
 - (d) An additional fee of \$40.00 for June registration.
 - (e) An additional fee of \$45.00 for July registration.
 - (f) An additional fee of \$50.00 for August registration.
 - (g) An additional fee of \$55.00 for September registration.

- (h) An additional fee of \$60.00 for October registration.
- (i) An additional fee of \$65.00 for November registration.
- (j) An additional fee of \$70.00 for December registration.

SECTION 2: If any part of this regulation is for any reason held to be invalid, such decision shall not affect the validity of the remaining portion of the regulation.

SECTION 3: All other Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4: This Ordinance shall take effect on approval and upon final passage and publication as required by law.




