## ORDINANCE NO. 2015-<u>3</u>

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA, AMENDING SECTION 30.026 PERTAINING TO GOLF CART COMMUNITIES TO CREATE THE RIVERSINK GOLF CART COMMUNITY; ADDING SEVERAL COUNTY ROADS IN THE RIVERSINK COMMUNITY TO THE LIST OF COUNTY ROADS ON WHICH GOLF CARTS MAY BE OPERATED; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

## **RECITALS:**

WHEREAS, the Board of County Commissioners of Wakulla County, Florida ("Board") previously enacted Wakulla County Ordinance No. 11-09, the Wakulla County Comprehensive Golf Cart Community Ordinance, which allows for the operation of Golf Carts on Designated County Roads in accordance with the provisions of the Ordinance and Chapter 316, Florida Statutes; and

WHEREAS, the Wakulla County Sheriff's Office conducted a study assessing the feasibility of allowing the use of golf carts on certain roads in the Riversink Community, taking into consideration the speed, volume, and character of motor vehicle traffic on said roads; and

WHEREAS, having considered the results of the aforementioned study, the Wakulla Community Traffic Safety Team unanimously recommended the creation of the Riversink Golf Cart Community, to include six county roads on which golf carts may be operated; and

WHEREAS, the Board now wishes to amend Section 30.026 of the Wakulla County Code of Ordinances to create the Riversink Golf Cart Community and establish the County Roads within that Community on which the operation of golf carts shall be permitted; and

WHEREAS, the Board further finds and determines that adoption of the amendments provided for herein serves the public welfare of the citizens of Wakulla County, Florida.

**NOW THEREFORE, BE IT ORDAINED** by the Board of County Commissioners of Wakulla County, Florida, that:

**ARTICLE 1. INCORPORATION OF RECITALS.** The above recitals are true and correct and are hereby incorporated by reference.

ARTICLE 2. AMENDMENT OF SECTION 30.026 OF THE WAKULLA COUNTY CODE OF ORDINANCES. The Board hereby amends section 30.026 of the Wakulla County Code of Ordinances, as follows:

Sec. 30.026. - Establishment of golf cart communities and designation of county roads.

(a) The board hereby establishes two three golf cart communities within Wakulla County as appropriate for golf cart operation:

(1) The Shell Point Golf Cart Community;

(2) The Panacea Golf Cart Community-; and

(3) The Riversink Golf Cart Community.

(b) Subject to the restrictions contained in this ordinance, the board hereby determines that the following county roads are appropriate for the operation of golf carts and are designated county roads in the Shell Point Golf Cart Community:

(3) Rising Tide Way,

(4) Alverson Way,

(d) Subject to the restrictions contained in this ordinance, the board hereby determines that the following county roads are appropriate for the operation of golf carts and are designated county roads in the Riversink Golf Cart Community:

(4) Marco Road,

(5) Pinewood Street,

(6) Pixie Circle,

(7) San Marcos Drive,

(d) (e) The county shall post, maintain, and replace signs, as needed, to inform residents of the communities and drivers of other motor vehicles that designated county roads may be subject to golf cart traffic. All costs associated with posting, maintaining, and replacing signs shall be paid by the members of the respective golf cart communities.

**ARTICLE 3. CODIFICATION IN THE CODE OF ORDINANCES.** It is the intention of the Board, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Wakulla County Code of Ordinances, and that the sections of this Ordinance may be renumbered to accomplish such intent.

**ARTICLE 4. SEVERABILITY.** Should any section or provision of this Ordinance or any portion thereof, or any paragraph, sentence, or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder hereof other than the part declared to be invalid.

**ARTICLE 5. EFFECTIVE DATE.** A certified copy of this Ordinance shall be effective 10 days after its enactment by the Board and filing with the Department of State.
