ORDINANCE NO. 15-011

AN ORDINANCE ADDING SECTION 51 d) and AMENDING SECTION 27 AND
APPENDIX A, OF THE CITY OF GREENWOOD BUSINESS LICENSE ORDINANCE,
CHAPTER 10, ARTICLE II OF THE CITY OF GREENWOOD CODE OF
ORDINANCES

WHEREAS, the City of Greenwood City Council wishes to promote the availability of a variety of locally grown and produced products; and

WHEREAS, the Council desires to have an Uptown Farmer's Market available for the convenience of the public; and

WHEREAS, the Council wishes to establish definitions and fees for participation in the Uptown Farmer's Market,

Now, **THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Greenwood that Chapter 10, Business Regulations, Solicitations and Sales, Article II. – Business Licenses be amended by adding Section 51 d) – Uptown Farmer's Market Vendors, Section 27 be amended by adding definitions and Appendix A be amended by adding Rate 8.6C :

Sec. 10-51 d) – A vendor participating in the Uptown Farmer's Market shall not be required to pay any vending fees if the business has an in-city Business License. Vendors without an in-city Business License shall be required to pay vending fees which will be in lieu of a Business License fee. The vending fee must be paid in full or city business license renewed prior to participation in the Uptown Farmer's Market. Vending fees are set forth in Appendix A.

Section 27 – Farmer/Producer: Farmers produce locally grown vegetables, fruit, nuts, grains, herbs, flowers or nursery crops from seed or plants. Beekeepers, egg farmers, poultry and livestock producers are considered farmers.

Processor: Vendors that use locally grown produce or other local agricultural products to make their products (such as jellies, jams, salsas, ciders, smoked meats, honey, handmade candies, etc.). This vendor does not operate a commercial business.

Artisan/Crafter: Produce original, unique, high quality, safe, garden/farm/ environmentally related items which brings some added value to the Market. All products must be actual work of the artisan/crafter.

Appendix A, Rate 8.6C **Vendor Fees for Uptown Farmer's Market**

Farmer/Producer: \$10 per day or \$20 per week or \$40 per calendar year.

Processor: \$15 per day or \$30 per week or \$60 per calendar year.

Artisan/Crafter: \$20 per day or \$40 per week or \$80 per calendar year.
