2. I will use only a 410 shotgun.
3. I will not begin shooting prior to 8:00 a.m. nor continue shooting after dark weekdays and Saturdays. I will not shoot at all on Sundays.
4. I will not shoot squirrels on any land upon which I do not have permission of the landowner.
5. I will not shoot in any manner or direction in which other property or persons could be injured.
6. I accept full and legal responsibility for all injuries and damages resulting from my actions.
7. I will comply with all state and federal hunting laws.

5. I will not shoot in any manner or direction in which other property or persons could be injured.
6. I accept full and legal responsibility for all injuries and damages resulting from my actions.
7. I will comply with all state and federal hunting laws.
