

RESOLUTION NO. 4410

(Authorizing the City Clerk to sell Certificates of Sale for APN 160-26-611-003 and APN 160-26-611-006 pursuant to NRS 271.575, and approving the Transfer of Certificates of Sale)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HENDERSON, NEVADA, AUTHORIZING THE CITY CLERK TO SELL CERTIFICATES OF SALE FOR APN 160-26-611-003 AND APN 160-26-611-006 PURSUANT TO NRS 271.575, AND APPROVING THE TRANSFER OF CERTIFICATES OF SALE.

- WHEREAS, the City Council of the City of Henderson, Nevada (the "City Council") created the City of Henderson, Nevada, Local Improvement District No. T-16 (The Falls at Lake Las Vegas) (the "District") pursuant to Ordinance No. 2323 adopted by the City Council on April 12, 2005 (as amended on January 21, 2014, by Ordinance No. 3120 and further amended on June 21, 2016, by Ordinance No. 3351, collectively, the "Creation Ordinance"); and
- WHEREAS, pursuant to the Creation Ordinance, the City Council levied Assessments (as defined in the Creation Ordinance) on the property within the District in accordance with, and as set forth in, the Assessment Roll (as defined in the Creation Ordinance); and
- WHEREAS, parcel APN 160-26-611-003, described as Lake Las Vegas Falls-Parent Final Map AMD, Plat Book 133 Page 63 Lot FF-1A, and parcel APN 160-26-611-006, described as Lake Las Vegas Falls-Parent Final Map AMD, Plat Book 133 Page 63 Lot S-18A, are located within the District, and have been levied assessments; and
- WHEREAS, the assessments for parcels APN 160-26-611-003 and APN 160-26-611-006 (collectively, the "Properties") were not paid when due; and
- WHEREAS, pursuant to NRS Chapter 271, a duly noticed and authorized sale of properties for default on special assessments was held on October 22, 2019, which included the Properties; and
- WHEREAS, the Properties were stricken off to the City on October 22, 2019, for the whole amount of the assessment due, including interest, penalties and costs, which were \$188,563.19 for APN 160-26-611-003, and \$162,571.81 for APN 160-26-611-006, resulting in the City being the holder of the Certificates of Sale, copies of which are attached as Exhibit A, consisting of two pages; and
- WHEREAS, the statutory redemption period for the Properties set forth in NRS 271.595(1) has passed; and
- WHEREAS, the City has received an offer to purchase the Certificates of Sale for the outstanding balance due, including interest as allowed by statute; and

Authorizing the City Clerk to sell Certificates of Sale for APN 160-26-611-003 and APN 160-26-611-006 pursuant to NRS 271.575, and approving the Transfer of Certificates of Sale

WHEREAS, NRS 271.575 allows the City Clerk to sell the Certificates of Sale after the expiration of the period of redemption if authorized by the City Council; and

WHEREAS, the City Clerk desires to sell the Certificates of Sale in accordance with the terms set forth in the Transfer of Certificates of Sale, attached as Exhibit B, consisting of one page; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Henderson, Nevada, that:

SECTION 1. The recitals set forth above are true and correct in all respects.

SECTION 2. The City Council of the City of Henderson hereby authorizes the City Clerk to sell and transfer the Certificates of Sale and to execute the Transfer of Certificates of Sale, attached as Exhibit B.

SECTION 3. The officers and employees of the City of Henderson be authorized and directed to do, or cause to be done, all acts and things necessary or appropriate to effectuate the provisions of this Resolution.

SECTION 4. The Resolution shall take effect immediately upon its adoption and approval.
