

ORDINANCE NO. 3977
(Repeal and Replace Ordinance No. 3810, and Adopt New 2023 Ward Map)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
HENDERSON, NEVADA, REPEALING ORDINANCE NO. 3810 IN ITS
ENTIRETY AND SETTING FORTH A NEW ORDINANCE
ESTABLISHING THE WARDS WITHIN THE CITY OF HENDERSON,
NEVADA, ACCORDING TO POPULATION AS DETERMINED BY THE
CITY'S DEMOGRAPHER AND AS REVISED FIGURES ARE PROVIDED
BY THE PLANNING DEPARTMENT OF THE CITY AS PROVIDED IN
SECTION 1.040 OF THE HENDERSON CITY CHARTER.

- WHEREAS, Nevada Revised Statutes 266.095 and City of Henderson Charter, Section 1.040 mandates the City must change the boundaries of its wards to ensure that the population of any ward does not exceed the population in any other ward by more than five (5) percent; and
- WHEREAS, the City of Henderson Department of Community Development and Services has calculated the City's population figures using the following data obtained annually in conjunction with all Clark County jurisdictions and the Nevada State Demographer: 1) a physical count of housing units; 2) persons per household data from the U.S. Census Bureau; and 3) occupancy rate data derived from City of Henderson residents' utility account records; and
- WHEREAS, the City of Henderson demographer has conducted an analysis based upon the revised population figures provided by the Department of Community Development and Services and has determined the current populations in Ward 2 and Ward 3 exceed the population in Ward 1 by more than five (5) percent; and
- WHEREAS, the City of Henderson City Council has determined that the measure used by the City Demographer is reliable; and
- WHEREAS, Nevada Revised Statutes 293.209, City of Henderson Charter, Section 1.040, and Henderson Municipal Code, Section 2.08.070 prohibit the changing of any election district boundary in the year of a city general election; and
- WHEREAS, the proposed boundary changes meet the required parameters set forth by Nevada Revised Statutes 266.095, and the City of Henderson Charter, Section 1.040; namely, wards must be as nearly equal in population as can be conveniently provided and no one ward exceeds any other by more than five (5) percent of population; no voting precinct has been split, and all precincts within a ward are contiguous; and

Repeal and Replace Ordinance No. 3810, and Adopt New 2023 Ward Map

WHEREAS, Henderson Municipal Code, Section 2.08.070 prohibits the modification of ward boundaries within six (6) months prior to the deadline for a candidate to file a declaration of candidacy; and

NOW, THEREFORE, the City Council of the City of Henderson, Nevada, does ordain:

SECTION 1. Ordinance No. 3810 is hereby repealed in its entirety. This repealer shall not be construed to revive any ordinance or ordinances heretofore repealed.

SECTION 2. The composition of the Wards, as constituted and aligned upon the passage of this ordinance, are as follows:

PLAN 1, consisting of 130 voting precincts, attached hereto as Exhibit A, consisting of one (1) page.

SECTION 3. If any section, subsection, sentence, clause, phrase, provision or portion of this Ordinance, or the application thereof to any person or circumstances, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions or provisions of this Ordinance or their applicability to distinguishable situations or circumstances.

Repeal and Replace Ordinance No. 3810, and Adopt New 2023 Ward Map

SECTION 4. All ordinances, or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Henderson, Nevada, in conflict herewith are repealed and replaced as appropriate.

SECTION 5. A copy of this Ordinance shall be filed with the office of the City Clerk, and notice of such filing shall be published once by title in the Las Vegas Review-Journal, a newspaper having general circulation in the City of Henderson, at least ten (10) days prior to the adoption of said Ordinance (Initial Publication). Following adoption by the City Council, this Ordinance shall be published by title together with the names of the Council members voting for or against passage (Final Publication). This Ordinance is scheduled for Final Publication on August 4, 2023, in the Las Vegas Review-Journal, at which time it will become effective.
