> A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HENDERSON, NEVADA, TO AMEND THE HENDERSON STRONG COMPREHENSIVE PLAN FOR THE PURPOSE OF REVISING THE MASTER TRANSPORTATION PLAN ROADWAY CLASSIFICATION MAP TO INCLUDE NEW ROADWAY ALIGNMENTS AND VACATE FUTURE PLANNED ROADWAYS WITHIN THE ELDORADO VALLEY MASTER PLAN, GENERALLY LOCATED WEST OF I-11 NEAR THE RAILROAD PASS OFF-RAMP, IN THE ELDORADO VALLEY AREA.

- WHEREAS, the City of Henderson adopted the Henderson Strong Comprehensive Plan (Plan) in July 2017; and
- WHEREAS, it is a standard best practice for communities to review and update the master plans; and
- WHEREAS, in accordance with Nevada Revised Statutes Chapter 278, the City of Henderson, Nevada, has deemed it necessary to amend the Plan, which, if implemented, would affect territory within Henderson's jurisdiction; and
- WHEREAS, since the adoption of the Henderson Strong Comprehensive Plan, future industrial development has been planned within the Eldorado Valley Master Plan that will provide private roadways internal to the development, thus eliminating the need for the planned public roadways; and
- WHEREAS, the City of Henderson has made application to amend the Plan to revise the Master Transportation Plan Roadway Classification Map to include new roadway alignments and vacate future planned roadways within the Eldorado Valley Master Plan, as depicted in Exhibit A, consisting of one (1) page; and
- WHEREAS, in accordance with Nevada Revised Statutes, the City of Henderson, Nevada, has deemed it necessary to amend the Plan for the purpose of amending the Master Transportation Plan Classification Map, which, if implemented, would affect territory within Henderson's jurisdiction; and
- WHEREAS, the Henderson Planning Commission has conducted the appropriate public hearing, received public comment, duly deliberated the proposal, and recommends approval of the Comprehensive Plan amendment; and
- NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Henderson, Nevada, that events, trends or facts occurring after adoption of the Plan have changed the character or condition of the area making the amendment to the Transportation Plan (MTP) Roadway Classification map necessary to reflect new roadway alignments and vacate future planned roadways within the Eldorado Valley Master Plan.


