

ORDINANCE NO. 4058

Amend Henderson Municipal Code Section 15.70.010 - Adopted

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON, NEVADA TO AMEND HENDERSON MUNICIPAL CODE SECTION 15.70.010 - ADOPTED - OF TITLE 15 - BUILDINGS AND CONSTRUCTION BY ADOPTING BY REFERENCE THE UNIFORM DESIGN AND CONSTRUCTION STANDARDS FOR POTABLE WATER DISTRIBUTION SYSTEMS, 4TH EDITION, 2025 AND AUTHORIZING THE CITY TO ISSUE AMENDMENTS.

WHEREAS, uniform standards for the design and construction of water distribution systems were first adopted within the Las Vegas Valley in 1995, are generally referred to as the Uniform Design and Construction Standards for Potable Water Distribution Systems (“UDACS”), and represent a collective effort of the following Southern Nevada water purveyors: Las Vegas Valley Water District, City of Boulder City, City of North Las Vegas, the Big Bend Water District, and the City of Henderson, Nevada (“City” or “Henderson”); and

WHEREAS, on May 6, 2014, the Henderson City Council (“City Council”) adopted the third edition of the UDACS through Ordinance No. 3159; and

WHEREAS, Southern Nevada water purveyors updated the UDACS in the Uniform Design and Construction Standards for Potable Water Distribution Systems, 4th Edition, 2025 and adoption of that updated standard is necessary; and

WHEREAS, the City, through its Department of Utility Services, periodically amends the UDACS through an addendum to clarify specific City requirements that might not be fully addressed in the then-current edition of the UDACS; and

NOW THEREFORE, the City Council of the City of Henderson, Nevada, does ordain:

SECTION 1. Section 15.70.010 - Adopted is hereby amended as follows:

15.70.010 - [UDACS adopted by reference](#)**[Adopted]**.

[Those certain documents, copies of which are on file in the offices of the city clerk in Henderson city hall, being marked and designated as the “Uniform Design and Construction Standards (UDACS) for Potable Water Systems Third Edition – 2010,” be and the same are designated as the City of Henderson uniform water system design and construction standards, and by said designation and reference are adopted and made part of this chapter, the same as if it were fully set forth herein.][The city adopts as its standards for the design and construction of water distribution systems the Uniform Design and Construction Standards for Potable Water Distribution Systems, 4th Edition, 2025, which standards, as amended, are referred to in the code as “UDACS” or “Uniform Design and Construction Standards for Potable Water Systems” or “Uniform Design and Construction Standards \(UDACS\) for Water Distribution Systems” or “Uniform Design and Construction Standards for Potable Water Systems \(UDACS\)” or “Uniform Design and Construction Standards” or “Uniform](#)

Design and Construction Standards (UDACS)” or “Uniform Design and Construction Standards for Water Distribution Systems, Clark County.” The UDACS is available online and one copy is on file in the office of the city clerk. The city may periodically amend the UDACS through an addendum approved in writing by the city’s director of utility services. Each addendum in effect shall be available online and a copy shall be on file in the office of the city clerk.

SECTION 2. The Uniform Design and Construction Standards for Potable Water Distribution Systems, 4th Edition, 2025 shall be effective on March 1, 2025, and any amendment of those standards shall be effective on the date specified by the City’s Director of Utility Services in their written approval of the particular amendment.

SECTION 3. If any section, subsection, sentence, clause, phrase, provision, or portion of this Ordinance, or the application thereof to any person or circumstances, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions or provisions of this Ordinance or their applicability to distinguishable situations or circumstances.

SECTION 4. All ordinances, or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Henderson, Nevada, in conflict herewith are repealed and replaced as appropriate.

SECTION 5. A copy of this Ordinance shall be filed with the office of the City Clerk and notice of such filing shall be published once by title in the Las Vegas Review-Journal, a newspaper having general circulation in the City of Henderson, at least ten (10) days prior to the adoption of said Ordinance (Initial Publication). Following adoption by the City Council, this Ordinance shall be published by title together with the names of the Council members voting for or against passage (Final Publication). This Ordinance is scheduled for Final Publication on February 7, 2025, in the Las Vegas Review-Journal, at which time it will become effective.
