AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON,
NEVADA, TO AMEND SECTION 2.05.010 – SALARY FOR MUNICIPAL COURT
JUDGE – AUTOMATIC INCREASE – OF THE HENDERSON MUNICIPAL
CODE.

WHEREAS, Ordinance 4057 was adopted on February 4, 2025; and

WHEREAS, Ordinance 3161 was adopted on May 20, 2014; and

WHEREAS, Ordinance 2505 was adopted in 2006; and

WHEREAS, Ordinance 2055 was adopted in 2001; and

WHEREAS, Ordinance 1835 was adopted in 1998; and

WHEREAS, amendments are required for clarification and consistency with the Henderson
Municipal Code; and

NOW, THEREFORE, the City Council of the City of Henderson, Nevada, does ordain:

SECTION 1. Chapter 2.05.010 – Salary for Municipal Court Judge is hereby amended as
follows:

Section 2.05.010 - Salary for municipal court judge.~~[—Automatic increase.]~~

Each elected municipal court judge shall, as of ~~[April 14, 2014]~~ the first pay
period that includes July 1, 2025, receive as compensation for his/her services
an annual salary of ~~[\$142,002.657.]~~ \$209,818.91. All elected municipal court
judges thereafter shall receive as compensation for their services an annual
salary equal to the annual salary of the incumbents within this classification.
