

ORDINANCE NO. 2884  
(Repeal Ordinance No. 2704 – Adopts 2011/2012 Ward and Precinct Map)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON, NEVADA, ESTABLISHING THE WARDS AND PRECINCTS FOR THE 2011 MUNICIPAL ELECTION AND REPEALING ORDINANCE NO. 2704 WHICH ESTABLISHED THE WARDS WITHIN THE CITY OF HENDERSON, NEVADA, FOR THE 2009 MUNICIPAL ELECTION ACCORDING TO POPULATION AS DETERMINED BY THE 2000 NATIONAL DECENNIAL CENSUS IN ORDER TO INCORPORATE CLARK COUNTY, NEVADA PRECINCT SPLITS, MERGERS, ADDITIONS, AND DELETIONS AND OTHER MATTERS RELATED THERETO.

WHEREAS, As outlined in the City of Henderson Charter, Section 1.040, an ordinance updating election precincts within existing ward boundaries must be adopted by December 31, 2010, to be effective for the 2011 municipal elections; and

WHEREAS, if an updated ward map reflecting the precinct revisions is not adopted by ordinance prior to December 31, 2010, the ward map will not meet the statutory requirements set forth by the City of Henderson Charter, Section 1.040, and Nevada Revised Statute Chapter 293.209; and

NOW, THEREFORE, the City Council of the City of Henderson does ordain:

SECTION 1. Ordinance No. 2704 is hereby repealed effective December 31, 2010.

SECTION 2. The composition of the Wards, as constituted and aligned upon the passage of this ordinance and effective as of December 31, 2010, are as set forth in Exhibit A, attached hereto.

SECTION 3. The total number of voting precincts in the City of Henderson is 171, as allocated to each ward in accordance to the updated ward map, attached hereto as Exhibit A, and distributed as follows:

SECTION 4. If any section, subsection, paragraph, clause or provision of this Ordinance shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section or subsection, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

SECTION 5. All ordinances, or parts of ordinances, sections, subsection, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Henderson, Nevada, in conflict herewith are repealed and replaced as appropriate.

SECTION 6. A copy of this Ordinance shall be filed with the office of the City Clerk, and notice of such filing shall be published once by title in the Review Journal, a newspaper having general circulation in the City of Henderson, at least ten (10) days prior to the adoption of said Ordinance, and following approval shall be published by title (or in full if the Council by majority vote so orders) together with the names of the Councilmen voting for or against passage for at least one (1) publication before the Ordinance shall become effective. This Ordinance is scheduled for publication on December 10, 2010, in the Review Journal.




