

ORDINANCE NO. 3031
(Amend Henderson Municipal Code Chapter 2.18)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON,
NEVADA, TO AMEND CHAPTER 2.18 - COMMEMORATIVE
BEAUTIFICATION COMMISSION - OF THE HENDERSON MUNICIPAL
CODE AND MATTERS PROPERLY RELATED THERETO.

- WHEREAS, The Commemorative Beautification Commission was established by the adoption of Ordinance 874 on December 6, 1982; and
- WHEREAS, amended by Ordinance 1008 on February 18, 1986, as outdated; and
- WHEREAS, further updated by Ordinance 1916 on June 15, 1999, to reflect the policies and practices at that time; and
- WHEREAS, is now being updated similarly; and

NOW, THEREFORE, the City Council of the City of Henderson, Nevada, does ordain:

SECTION 1. Chapter 2.18 Commemorative Beautification Commission is hereby amended as follows:

2.18.010 Board established.

There exists a commemorative beautification commission (CBC), which was originally established by 1982 Ordinance No. 874 and amended by 1986 Ordinance No. 1008 and further updated by Ordinance 1916 on June 15, 1999, to reflect the policies and practices at that time

2.18.020 Purpose.

The purpose of the CBC shall be to:

1. nominate for commemoration those individuals who, through exceptional effort, have contributed in a substantial manner to the general betterment of the city and its inhabitants;

2. to identify [develop plans for the beautification of] streets, highways, public parks, and other public areas within the limits of the City of Henderson for potential beautification.

2.18.030 Membership.

The CBC consists of seven members. Each councilmember shall appoint one member to the CBC from his or her ward, and shall have the sole responsibility for nominating a citizen who resides in that ward to fill vacancies that arise. The mayor shall make three at-large appointments from [three] any [different] ward[s]. All nominations shall be voted upon by the mayor and councilmembers.

The term of each member shall commence at the next CBC meeting following the appointment by the mayor and city council and shall automatically expire *at the next meeting following the conclusion of the term of the appointing member of the city council.*

No citizen may serve on the CBC for any uninterrupted period longer than eight years unless approved by council.

No member of the CBC may serve concurrently on any other permanent city council created board or commission.

Should a CBC member voluntarily move from the ward from which he or she was appointed, his or her membership shall automatically expire; however, should a [CTAB] CBC member be involuntarily moved from the ward from which they were appointed due to a realignment of council ward boundaries, the member shall continue to serve until the end of his or her appointed term.

2.18.040 Officers.

The CBC shall elect a chair[man]person and vice- chair[man]person from its members each year.

The City of Henderson parks and recreation director, or his designee, shall serve as the ex officio secretary of the commission.

2.18.050 Bylaws.

The CBC shall adopt bylaws establishing meeting times and procedural rules necessary for the efficient conduct of its business.

Proposed bylaws and amendments to the bylaws shall be presented to the commission for consideration through the regular agenda process at two consecutive meetings before adoption. An affirmative vote of a two-thirds majority of the entire membership of the commission shall be required for adoption.

2.18.060 Subcommittees.

The commission may create such subcommittees as it deems necessary to efficiently conduct business.


[2.18.070 Appeals.

Appeals of final action of the commission shall be made to the city council.

- SECTION 2. If any section, subsection, paragraph, clause or provision of this Ordinance shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section or subsection, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.
- SECTION 3. All ordinances, or parts of ordinances, sections, subsection, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Henderson, Nevada, in conflict herewith are repealed and replaced as appropriate.
- SECTION 4. A copy of this Ordinance shall be filed with the office of the City Clerk, and notice of such filing shall be published once by title in the Review Journal, a newspaper having general circulation in the City of Henderson, at least ten (10) days prior to the adoption of said Ordinance, and following approval shall be published by title (or in full if the Council by majority vote so orders) together with the names of the Councilmen voting for or against passage for at least one (1) publication before the Ordinance shall become effective. This Ordinance is scheduled for publication on July 5, 2013, in the Review Journal.
