- WHEREAS, the operation of golf carts on certain streets would be limited to direct, maintenance trips between the two sites; and
- WHEREAS, the operation of golf carts on certain streets would be consistent with the existing permitted streets which allow golf cart operation; and
- NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Henderson, Nevada, that the schedule attached to Chapter 10.62 of the Henderson Municipal Code, describing those certain streets in which golf cart operation is allowed, be amended to add those certain streets and portions of streets as depicted in Exhibit A, Proposed Golf Cart Boundary, consisting of one (1) page.
