ORDINANCE NO. 11 OF 2017

AN ORDINANCE TO DECLARE AS SURPLUS AND NOT NEEDED FOR A PUBLIC PURPOSE, TO SECURE BIDS AND SELL TO THE HIGHEST BIDDER THE PROPERTY OWNED BY THE CITY OF WINNFIELD, LOUISIANA KNOWN AS THE VASSERETTE PROPERTY CONTAINING 14.179 ACRE TRACT OF LAND WITHIN THE NW/4 OF THE SE/4 AND THE NE/4 OF THE SW4 IN SECTION 26, T11W, R3W, WINNFIELD, WINN PARISH, LOUISIANA; AND ALL IMPROVEMENTS THEREON, TO PROVIDE FOR A MINIMUM BID OF TWO HUNDRED FIFTY THOUSAND (\$250,000.00) DOLLARS, TO PROVIDE FOR RELATED MATTERS, AND TO PROVIDE AN EFFECTIVE DATE FOR BIDS TO BE PRESENTED TO THE CITY OF WINNFIELD.

BE IT ORDAINED by the Mayor and City Council of the City of Winnfield, Louisiana, that the property described herein known as the Vasserette building and property containing 14.179 acres within the NW/4 of the SE/4 and the NE/4 of the SW/4 in Section 26, T11W, R3W, Winnfield, Winn Parish, Louisiana, a is hereby declared surplus and not useful for any public purpose.

BE IT FURTHER ORDAINED AND RESOLVED that the said property is to be sold to the highest bidder, with a minimum bid of TWO HUNDRED FIFTY THOUSAND (\$250,000.00) DOLLARS, on such terms and conditions as may be prescribed by the Mayor and City Council of the City of Winnfield, Louisiana.

BE IT FURTHER ORDAINED by the Mayor and City Council of the City of Winnfield, Winn Parish, Louisiana, that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED by the Mayor and City Council of the City of Winnfield, Winn Parish, Louisiana that this ordinance is deemed severable and should any part or portion hereof be declared invalid or unconstitutional, then the remainder of the ordinance which can be enforced without regard to such invalid or unconstitutional part or portion shall remain in full force and effect.

BE IT FURTHER ORDAINED that this ordinance shall be effective upon publication hereof as provided by law and the expiration of all required legal delays.
