

AN ORDINANCE TO ESTABLISH THE FISCAL YEAR OF THE CITY OF DORAVILLE, GEORGIA, AMENDING SECTIONS 2-82 AND 2-85 OF THE CODE OF ORDINANCES, CITY OF DORAVILLE, GEORGIA, TO PROVIDE FOR SAME; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

WHEREAS, the Mayor and Council of the City of Doraville are charged with the protection of the public health, safety, and welfare of the citizens of the City of Doraville; and

WHEREAS, the Charter of the City of Doraville, Georgia (the “City Charter”), requires that the City’s fiscal year be set by ordinance; and

WHEREAS, the City of Doraville currently operates on a fiscal year that begins on July 1 of each year and ends on June 30 of the following calendar year; and

WHEREAS, beginning with Fiscal Year 2023 and for all subsequent fiscal years, the Mayor and Council desire that the City’s fiscal year begin on October 1 of each year and end on September 30 of the following calendar year; and

WHEREAS, the Mayor and Council desire to amend Section 2-82 (entitled “Fiscal year”) and Section 2-85 (entitled “When to be adopted”) of the Code of Ordinances, City of Doraville, Georgia (the “City Code”), in order to effect said change and establish the City’s fiscal year.

NOW, THEREFORE, the Mayor and Council of the City of Doraville hereby ordain that:

SECTION 1. Section 2-82 of the City Code is hereby amended by deleting same in its entirety and substituting in lieu thereof a new Section 2-82 to read as follows:

“Section 2-82. Fiscal year.

The City shall be operated on a fiscal year basis.

- (a) For Fiscal Year 2022 and all prior fiscal years, the fiscal year shall commence on July 1 of each year and end on June 30 of the following calendar year.
- (b) The City shall adopt a three-month budget for the fiscal period running from July 1, 2022, through September 30, 2022.
- (c) For Fiscal Year 2023 and all subsequent fiscal years, the fiscal year shall commence on October 1 of each year and end on September 30 of the following calendar year.”

SECTION 2. Section 2-85 of the City Code is hereby amended by deleting same in its entirety and substituting in lieu thereof a new Section 2-85 to read as follows:


“Section 2-85. When to be adopted.

The City Manager or designee's proposed budget, as amended by the Council, shall be presented and adopted by a majority vote of the City Council prior to the commencement of each fiscal year at a regularly scheduled or specially called meeting of the Mayor and City Council.”

SECTION 3. This Ordinance shall become effective immediately upon its adoption by the Mayor and Council. This Ordinance hereby repeals any and all conflicting ordinances or resolutions.
