

ORDINANCE NO: 13-2013

**AN ORDINANCE FIXING AND ESTABLISHING SPEED LIMITS IN THE CITY OF ATMORE, ALABAMA AND ITS POLICE JURISDICTION:**

BE IT ORDAINED by the City Council of the City of Atmore, Alabama as follows:

SECTION 1. No person shall operate a motor vehicle at a greater speed than fifty-five (55) miles per hour in the following listed zones of the City.

- (1) On AL 21 between Milepost 7.250 (Curtis St., Node 7494) and Milepost 7.30
- (2) On AL 21 between Milepost 8.32 and Milepost 10.350
- (3) On US 31 (AL 3) between Milepost 38.952 (West City Limits) and Milepost 40.383 (Tennant Dr., Node 580)
- (4) On US 31 (AL 3) between Milepost 42.300 and Milepost 42.551 (East City Limits)

SECTION 2. No person shall operate a motor vehicle at a greater speed than forty-five (45) miles per hour in the following listed zone of the City.

- (1) On AL 21 between Milepost 0.000 (Florida State Line) and Milepost 1.430 (Craig St., Node 119)
- (2) On AL 21 between Milepost 2.470 (Patterson St., Node 458) and Milepost 3.270 (Brushy Creek)
- (3) On AL 21 between Milepost 7.30 and Milepost 8.32
- (4) On AL 21 between Milepost 10.350 and Milepost 10.890
- (5) On AL 21 between Milepost 11.740 and Milepost 12.280
- (6) On US 31 (AL 3) between Milepost 40.383 (Tennant Dr., Node 580) and Milepost 40.947 (Highland Ave., Node 81)
- (7) On US 31 (AL 3) between Milepost 41.451 (Jackson St., Node 191) and Milepost 42.300

SECTION 3. No person shall operate a motor vehicle at a greater speed than forty (40) miles per hour in the following listed zone of the City.

- (1) On AL 21 between Milepost 10.890 and Milepost 11.740

SECTION 4. No person shall operate a motor vehicle at a greater speed than thirty-five (35) miles per hour in the following listed zone of the City.

- (1) On AL 21 between Milepost 1.430 (Craig St., Node 119) to Milepost 1.702 (Owens St., Node 113)
- (2) On AL 21 between Milepost 2.080 (Ashley St., Node 315) to Milepost 2.466 (Patterson St., Node 458)
- (3) On US 31 (AL 3) between Milepost 40.947 (Highland Ave., Node 81) and Milepost 41.451 (Jackson St., Node 191)

SECTION 5. No person shall operate a motor vehicle at a greater speed than thirty (30) miles per hour in the following listed zone of the City.

(1) On AL 21 between Milepost 1.702 (Owens St., Node 113) and Milepost 2.080 (Ashley St., Node 315)

SECTION 6. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 7. This ordinance shall become effective immediately upon its passage, approval and publication as provided by law.
