

ORDINANCE 1518

AN ORDINANCE OF THE CITY OF TEMPLE TERRACE, FLORIDA, AMENDING CHAPTER 2, ADMINISTRATION AND ELECTIONS, ARTICLE II, ELECTIONS, OF THE CODE OF ORDINANCES OF THE CITY OF TEMPLE TERRACE; AMENDING SECTION 2-27 QUALIFYING PERIOD FOR THE REGULAR ELECTION OF CITY COUNCIL AND/OR MAYOR; PROVIDING FOR SEVERABILITY OF PROVISIONS; PROVIDING FOR CODIFICATION; REPEALING ALL ORDINANCES IN CONFLICT HERewith AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in order to develop an absentee ballot in a timely manner, the Office of the Supervisor of Elections of Hillsborough County has requested the City of Temple Terrace move its qualifying period about 14 days; and

WHEREAS, after due consideration, the Mayor and City Council of the City of Temple Terrace, Florida, concur with the changes to the qualifying period as recommended by the office of the Supervisor of Elections of Hillsborough County, relative to the qualifying dates for candidates seeking election to the office of City Council or Mayor of the City of Temple Terrace, for the purpose of developing an absentee ballot in a timely manner, and find it necessary to amend Section 2-27 (a) Qualifying Period for the Regular Election of City Council and/or Mayor.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TEMPLE TERRACE, FLORIDA THAT:

1. Section 2-27 – Qualifying period for the regular election of city council and/or mayor.

(a) For any regular election of the city council and/or mayor, the qualifying period shall be defined as from noon the ~~seventy-first~~ eighty-fifth day prior to the regular election for the office of city council and/or mayor, to noon the ~~sixty-seventh~~ eighty-first day prior to the regular election for the office of city council and/or mayor.
2. This ordinance shall take effect immediately upon becoming law.
3. All ordinances or parts of ordinances not specifically in conflict herewith are hereby continued in full force and effect, but all ordinances or parts of ordinances in conflict herewith are hereby repealed.
