Dear Ladies and Gentlemen:

In accordance with Section 6-3 (b) of the Chelsea City Charter, the following actions were approved at the September 3, 2019 Traffic and Parking Commission Meeting:



Item #4 - To amend the Citywide Parking Program Article 13 of the Traffic and Parking Rules and Regulations to the following sections:

1. To amend Section 13-5-5 (B) of the Non-Residential Parking Program to read as:  
"Trade/Craft Contractor Parking Passes - the fee for acquiring a trade/craft contractor pass is five dollars (\$5.00) a day for daily pass, fifteen dollars (\$15.00) a week for weekly pass or thirty dollars (\$30.00) a month for a monthly pass."
2. To amend Section 13-5-4.2 (B) of the Non-Residential Parking Program to read as:  
"Landlord Visitor Parking Passes - Landlord visitor passes are ten dollars (\$10.00) for a six (6) month period or any part thereof. A lost, stolen or damaged landlord visitor parking pass may be replaced one time at the discretion of the Parking Clerk."

Item #6 - To install a removable rubber speed bump at 125 Marlborough Street and 70 Shawmut Street as a pilot program for two months based on the request submitted by Councilor Enio Lopez.

Item #9 - To post a "No Parking This Side" sign in front of 92 Chester Avenue based on the request submitted by Councilor Judith Garcia.

Item #13 - To post a handicap sign at 65 Fourth Street based on the application submitted by Reina Villanueva.
