**AN ORDINANCE AMENDING APPENDIX “A” ENTITLED “FEE SCHEDULE”  
OF THE CODE OF ORDINANCES, VILLAGE OF BROOKFIELD, ILLINOIS,  
REGARDING CONTINUATION OF WATER SERVICE FEES**

**WHEREAS**, the Illinois Municipal Code (65 ILCS 11-117-12; 11-126-4; 11-129-10; 11-139-8) authorize the corporate authorities of the Village of Brookfield (the “Village”) to fix utility rates for municipal utilities;

**WHEREAS**, in the opinion of a majority of the corporate authorities of the Village, it is advisable, necessary and in the public interest that the Village amend the provisions of the Code of Ordinances Village of Brookfield, Illinois, pertaining to the rates charged to the customers of the Village for turning on their water after delinquency; and

**WHEREAS**, in the opinion of a majority of the corporate authorities of the Village, it is advisable, necessary and in the public interest that the Village amend Appendix “A,” entitled “Fee Schedule,” of the Code of Ordinances, Village of Brookfield, Illinois, as amended;

**NOW, THEREFORE, BE IT ORDAINED** by the Village President and the Board of Trustees of the Village of Brookfield, Cook County, Illinois, as follows:

**Section 1:** The corporate authorities hereby incorporate the foregoing preamble clauses into this ordinance and make the findings as hereinabove set forth.

**Section 2:** Appendix “A,” entitled “Fee Schedule,” of the Code of Ordinances, Village of Brookfield, Illinois, as amended, is hereby further amended, in relevant sections, to read as follows:

**Section 3:** If any provisions or portion of this ordinance or its application to any person, entity or property is held invalid, such invalidity shall not affect the application or validity of any other provisions or portions of this ordinance; and, to that end, all provisions and portions of this ordinance are declared to be severable.

**Section 4:** All ordinances or parts of ordinances in conflict with these ordinance revisions and additions are repealed, insofar as a conflict may exist.

**Section 5:** This ordinance shall be in full force and effect following its passage, approval and publication in pamphlet form as provided by law.
