ORDINANCE NO. <u>4605</u>

CREATING SEC. 2-412 IN CHAPTER 2 OF THE MICHIGAN CITY MUNICIPAL CODE TO CREATE A CDBG FUND TO RECEIPT FUNDING AWARDED TO THE CITY FROM HUD THROUGH THE CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY (CARES) ACT

WHEREAS, the federal government has enacted the Coronavirus Aid, Relief and Economic Security Act (hereinafter referred to as "CARES") as a result of which the City of Michigan City, Indiana is anticipating receiving \$613,335 dollars in federal government assistance for the City's Community Development Block Grant Program ("CDBG") as a result of the financial impacts the City has sustained from COVID-19; and

WHEREAS, on March 18, 2021, the Indiana State Board of Accounts (hereinafter referred to as "SBOA") issued State Examiner Directive 2020-3 and Memorandum to Indiana counties, cities, and towns regarding the accounting process for CARES funding; and

WHEREAS, pursuant to the aforementioned SBOA guidance, each unit of government that receives an allocation from the Coronavirus Aid, Relief and Economic Security Act under, shall establish, by ordinance, a separate grant fund to receive the CARES funding; and

WHEREAS, the need exists to now establish a CDBG Coronavirus Aid, Relief and Economic Security Act Fund for the City to receipt CARES monies and to comply with the aforementioned directives issued by the SBOA.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Michigan City, Indiana, that Sec. 2-412 be created in Chapter 2 of the Michigan City Municipal Code to read as follows:

Sec. 2-412. CDBG Coronavirus Aid, Relief and Economic Security Act Fund.

There is hereby created a CDBG Coronavirus Aid, Relief and Economic Security Act Fund, which shall be known as "CDBG Coronavirus Aid, Relief and Economic Security Act Fund #0153." All monies received from the CDBG Coronavirus Aid, Relief and Economic Security Act Fund must be receipted into this Fund. In accordance with the requirements under the CARES Act, the monies in this Fund may only be used in accordance with the Coronavirus Aid, Relief and Economic Security Act, Relief and Economic Security Act, the monies in this Fund may only be used in accordance with the Coronavirus Aid, Relief and Economic Security Act (CARES Act), Pub. This Ordinance shall be effective upon passage and approval by the Mayor.
