ORDINANCE

Chapter 54. Occupational License: Amendments to the Municipal Code City of Alma shall be amended as follows:

(A) By deleting Section 54-3. - Deadline for payment and substituting the following:

Section 54-3. - Deadline for payment.

Each such occupational tax shall be for each calendar year. Said occupational tax shall be due and payable January 1st of each calendar year and shall be delinquent if not paid by March 31st of each calendar year.

(B) Section 54-14. - Delinquency penalty. Shall be amended by deleting said Code Section and substituting the following:

Section 54-14. - Delinquency penalty. All licenses under this chapter which are not paid for by March 31st of each calendar year or at the time of commencement of business if after March 31st, will bear penalty at the rate of ten percent of the amount due and unpaid of \$25.00, whichever is greater.

 - a) Reject the single bid from K-DUG Construction Co. of Patterson, GA of \$1,123,436.24 to change the project scope and meet the budgeted funds available.
 - b) Roberts Civil Engineering recommends the project's scope of services be changed and re-bid.
 - c) The goals are for the project to a) be constructed within the funds available (\$800,000.00), and b) attract multiple bidders.

Motion to reject a bid from K-DUG Construction Co. and change the project scope to meet budgeted funds by Council member Waters. Seconded by Council member Sweat. Motion carried.
