INTRODUCTION TO PROPOSED ORDINANCE AMENDMENT  
Parks and Recreation

The Delta Township Board introduced the following ordinance amendment at its regular meeting held on April 21, 2025.

The Delta Township Board will consider adoption of the following ordinance amendment at its regular meeting scheduled for 6:00 p.m. on May 5, 2025.

The Delta Township Board adopted the following ordinance amendment at its regular meeting held on Monday, May 5, 2025.

THE CHARTER TOWNSHIP OF DELTA ORDAINS TO AMEND THE PARKS  
RECREATION ORDINANCE OF DELTA TOWNSHIP AS SUMMARIZED  
BELOW:

**Amendment to Section 30-1 Definitions** to add term “Path” to ensure that the definitions are consistent with the proposed amendments.

*Path means a designated track or trail, which may be paved or unpaved, that is intended for public use for non-motorized transportation within a park or connecting one or more parks or other public recreational facilities.*

**Amendment to Section 30-16 Operations of Bicycle** to amend to read as follows:

- (a) Bicycles shall be operated as closely to the right-hand curb or right-hand side of the path or trail as conditions will permit and not more than two bicycles shall be operated abreast.
- (b) It shall be unlawful for the operator of any bicycle, upon any path or trail to carry any person upon the handlebar or frame of any bicycle, or any person to so ride upon such bicycle.

- (c) Bicycles may be operated upon such paths or trails as may be posted allowing such use.

SEVERABILITY. If any clause, sentence, paragraph, or part of this Ordinance shall for any reason be finally adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance but shall be confined in its operation to the clause, sentence, paragraph or part thereof directly involved in the controversy in which such judgment is rendered.

REPEAL. All ordinances or parts of ordinances of the Charter Township of Delta inconsistent herein are hereby repealed so far as they may be inconsistent with the provisions of this Ordinance.

EFFECTIVE DATE. This Ordinance shall take effect upon final publication as required by law.
