**ORDINANCE AMENDING TITLE 3, CHAPTER 31, SECTION 31.029  
REGARDING FIREFIGHTER AND POLICE OFFICER APPOINTMENTS**

**WHEREAS**, the Village of Schaumburg has created a Board of Fire and Police Commission pursuant to Illinois law; and

**WHEREAS**, the Fire Chief has recommended that Firefighters and Police Officers age requirements be updated in compliance with state law; and

**WHEREAS**, the responsibilities and duties of the Fire and Police Commission are to make initial appointments and the Commission concur with the recommended changes; and

**WHEREAS**, the Village of Schaumburg is a home rule municipality and pursuant to the Illinois Constitution, Article VII, Section 6, has certain powers which it is exercising.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:**

**SECTION ONE:** That Title 3, Chapter 31, Section 31.029 (E) (1) be amended to read as follows:

(a) Applicants for appointment as full time firefighters shall have an associate degree or bachelor's degree from an accredited university or college. Applicants shall be a minimum age of twenty one (21) years or a maximum age of thirty five (35) years or as otherwise allowed by state law.

(b) Applicants for appointment as full-time police officers shall have a bachelor's degree from an accredited university or college. Applicants shall be a minimum age of twenty-one (21) years or a maximum age of thirty five (35) years or as otherwise allowed by state law.

**SECTION TWO:** That this Ordinance shall be in full force and effect, after passage, approval and publication as required by law.
