**AN ORDINANCE AMENDING TITLE 13, CHAPTER 132, SECTION 132.17
WITH REGARD TO THE REGULATION OF FIREWORKS**

WHEREAS, the Village of Schaumburg, as a home rule unit of local government as provided by Article VII, Section 6 of the Illinois Constitution of 1970, has the authority to exercise any power and perform any function pertaining to its government and affairs except as limited by Article VII, Section 6 of the Illinois Constitution of 1970; and

WHEREAS, Section 132.17 of the Schaumburg Village Code currently regulates the possession of fireworks within the Village, and references an outdated version of the International Fire Code; and

WHEREAS, the Village desires to amend Section 132.17 to reference the current version of the International Fire Code; and

WHEREAS, the Village President and Board of Trustees of the Village of Schaumburg have determined that said amendment is in the best interest of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:

SECTION ONE: That Title 13, Chapter 132, Section 132.17 is hereby amended to read as follows:

§ 132.17 - POSSESSION OF FIREWORKS PROHIBITED.

It shall be unlawful for any person, firm or corporation to knowingly possess, sell, ignite, discharge, or display any type of fireworks as defined in 425 Illinois Compiled Statutes 35 et seq., Fireworks Use Act, within the corporate limits of the village unless a special permit to exhibit or discharge fireworks has been granted by the president and board of trustees issued by the fire chief or his designee. Any permit to exhibit or discharge fireworks shall be subject to the following:

- (A) Current adopted fire code of the Village of Schaumburg;
- (B) The discharge of fireworks may only occur on Friday, Saturday, any federal holiday, or the evening before any federal holiday;
- (C) No discharge of fireworks shall begin later than 10:30 p.m.;
- (D) All discharge of fireworks shall conclude by 11:00 p.m.;
- (E) An exception to the above regulations to the permit may be granted by the village manager in writing;
- (F) The applicant shall reimburse the Village of Schaumburg for the cost of fire protection services during the inspection and monitoring of the fireworks. The village may require a deposit to cover the anticipated costs of providing the services.
