

ORDINANCE NO. 1101

AN ORDINANCE AMENDING THE NICHOLS HILLS CITY CODE REGARDING RESTRICTIONS ON SMOKING AND USES OF TOBACCO PRODUCTS AND VAPOR PRODUCTS AND PROVIDING FOR PENALTIES AND FINES FOR VIOLATION OF SUCH RESTRICTIONS; REPEALING ALL CONFLICTING ORDINANCES OR PARTS OF ORDINANCES; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

EMERGENCY ORDINANCE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NICHOLS HILLS, OKLAHOMA:

Section 1. Chapter 24 of the Nichols Hills City Code is hereby amended by adding Article IV, which Article IV reads as follows:

ARTICLE IV. RESTRICTIONS ON SMOKING AND USE OF TOBACCO PRODUCTS AND VAPOR PRODUCTS

Sec. 24-121. – Definitions.

- (a) *Indoor Area* means any enclosed area used or visited by employees or the public, at all times, regardless of whether work is being performed. Indoor Area includes work areas, employee lounges, restrooms, conference rooms, classrooms, employee cafeterias, hallways, any other spaces used or visited by employees, as well as all space between a floor and ceiling that is predominantly or totally enclosed by walls or windows, regardless of doors, doorways, open or closed windows, stairways, or the like.
- (b) *City Property* means all buildings, Indoor Areas, and Outdoor Areas, including but not limited to parks and recreational areas, and other property, or portions thereof, owned or operated by the City, including but not limited to vehicles and equipment owned by the City.
- (c) *Outdoor Area* means any area that is not an Indoor Area, and includes parks and recreational areas, as well as sidewalks and paths located within such areas. Outdoor Area shall not include streets and sidewalks outside of parks and recreational areas.
- (d) *Smoking* means the carrying or possession of a lighted cigar, cigarette, pipe, or other lighted smoking device.
- (e) *Tobacco Product* means any product that contains tobacco and is intended for human consumption. Tobacco Product does not include any product approved by

the United States Food and Drug Administration for sale as a tobacco cessation product.

- (f) *Vapor Product* means any noncombustible product, that may or may not contain nicotine, that employs a mechanical heating element, battery, electronic circuit, or other mechanism, regardless of shape or size, that can be used to produce a vapor in a solution or other form. Vapor Product shall include any vapor cartridge or other container with or without nicotine or other form that is intended to be used with an electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, or similar product or device and any vapor cartridge or other container of a solution, that may or may not contain nicotine, that is intended to be used with or in an electronic cigarette, electronic cigar, electronic cigarillo, or electronic device.

Sec. 24-122. – Prohibited Conduct.

- (a) Smoking Tobacco Products is prohibited in all places in which Smoking Tobacco Products is prohibited by Oklahoma state law.
- (b) Smoking is prohibited on or within all City Property, including parks and recreational areas.
- (c) Using Tobacco Products or Vapor Products is prohibited on or within all City Property, including parks and recreational areas.
- (d) Nothing in this article prohibits any person or entity from separately prohibiting Smoking or the use of Tobacco Products or Vapor Products on their property, even if the Smoking or the use of Tobacco Products or Vapor Products is not prohibited in that area by this section.
- (e) No person or entity shall knowingly permit Smoking or the use of Tobacco Products or Vapor Products in an area that is under the control of that person or entity and in which Smoking or the use of Tobacco Products or Vapor Products is prohibited by this section.
- (f) No person or entity shall permit the placement of ash receptacles, such as ash trays or ash cans, within an area under the control of that person or entity and in which Smoking or the use of Tobacco Products or Vapor Products is prohibited by this section. The presence of ash receptacles shall not be a defense to a charge of Smoking or the use of Tobacco Products or Vapor Products in violation of any provision of this section.
- (f) No person or entity shall intimidate, threaten, or otherwise retaliate against another person or entity that seeks to attain compliance with this article.

Sec. 24-123. – Signs.

For restrictions on Smoking or the use of Tobacco Products or Vapor Products within City owned or operated property, including parks and recreational areas:

- (a) The City Manager or his/her designee shall be responsible for ensuring the posting of signs or decals within City owned or operated parks and recreational areas and Indoor Areas, where signs or decals are necessary in the judgment of the City Manager.
- (b) For restrictions on Smoking or the use of Tobacco Products or Vapor Products within City owned or operated parks and recreational areas, new signs shall be weather-resistant, at least 15 inches by 15 inches in size, with lettering of at least 1 inch, and shall clearly state that smoking and use of tobacco products or vapor products is prohibited.
- (c) For restrictions on Smoking or the use of Tobacco Products or Vapor Products within Indoor Areas, the sign or decal shall be at least 4 inches by 2 inches in size and shall clearly state that smoking and use of tobacco products or vapor products is prohibited or that a tobacco-free environment is provided.
- (d) The presence or absence of signs or decals shall not be a defense to a charge of Smoking or the use of Tobacco Products or Vapor Products in violation of any provision of this article.

Sec. 24-124. – Penalties and Enforcement.

- (a) Enforcement of this article shall be the responsibility of the City of Nichols Hills police department. In addition, any peace officer or code enforcement official may enforce this article.
- (b) Each instance of Smoking, use of Tobacco Products or Vapor Products or possession of lighted Tobacco Products or Vapor Products in violation of this article is a nuisance.
- (c) Any person who knowingly violates this article shall be punished in the first instance by a warning, and in the second and subsequent instances, shall, upon conviction, be punished as provided in section 14-106 of this Code.

Section 24-125 – Statutory Construction and Severability.

It is the intent of the City Council of the City of Nichols Hills to supplement applicable state and federal law and not to duplicate or contradict such law. The provisions of this ordinance are severable, and the invalidity of any provision of the ordinance shall not affect other provisions of the ordinance, which can be given effect without the invalid provision.

Section 2. Chapter 14, Section 14-106 of the Nichols Hills City Code is hereby amended as follows, with new language underlined, to wit:

Sec. 14-106. Amount and Schedule of fines.

Unless directed otherwise by the presiding municipal judge, for citations for violations of this Code issued on or after July 17, 2013, the amount of the fine (inclusive

of court costs imposed by section 14-103 of this chapter and state-mandated penalty assessments as provided in Title 20, Oklahoma Statutes, §§ 1313.2, 1313.3, 1313.4 and other applicable state law), which may be accepted by the clerk of the court in satisfaction of certain violations shall be as follows:

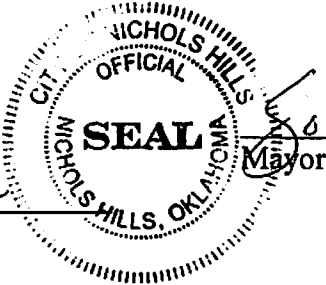
