

## ORDINANCE NO. 2015-06

### AN ORDINANCE OF THE CITY OF ANGOON TO STRIKE CHAPTER 4.44.020 FROM THE MUNICIPAL CODE, SCALE.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ANGOON, ALASKA:

- Section 1. Classification. This ordinance is of a general and permanent nature and the code sections amended hereby shall become part of the city code.
- Section 2. Severability. If any provisions of this ordinance or any application thereof to any person or circumstances is held invalid, the remainder of this ordinance and the application to other persons shall not be affected thereby.
- Section 3. Penalty. Violations of the sections herein enumerated shall be punishable as specified in the Angoon Municipal Code.
- Section 4. The City Of Angoon municipal code shall be amended as follows, with each item ~~struck through~~ to be removed from the code.


