



## **Ordinance 20-04**

### **An Ordinance Repealing and Replacing the Landfill Ordinance**

**BE IT ENACTED BY THE CITY OF ANGOON, ALASKA AS FOLLOWS:**

**Title 8 – Health and Safety, Chapter 12 – Landfill Use is repealed in its entirety and replaced with the following:**

#### **8.12 – Landfill Use**

##### **8.12.010 – Purpose**

#### **8.12 – Landfill Use**

##### **8.12.010 – Purpose**

In order to establish an enforceable method of collecting revenues from use of the city landfill to finance Landfill Operations and supplement the Angoon General Fund, a policy for landfill use shall be established.

##### **8.12.020 – Hours of Operation**

The City of Angoon Landfill Hours of Operation shall be established and modified through a resolution titled, “A Resolution Establishing/Amending the City of Angoon Landfill Hours of Operation”. A resolution to amend the Landfill Hours of Operation shall repeal the previous resolution in which the hours of operation were established or amended.

##### **8.12.030 – Fee Schedule**

The City of Angoon Landfill Use Fee Schedule shall be established and modified through a resolution titled, “A Resolution Establishing/Amending the City of Angoon Landfill Use Fee Schedule”. A resolution to amend the Landfill Use Fee Schedule shall repeal the previous resolution in which the fee schedule was established or amended.

##### **8.12.040 – Terms and Conditions**

A. No refuse may be deposited at the landfill if no landfill attendant is present to receive the refuse.

B. Refuse shall be deposited in the designated area inside the landfill, at the direction of any posted signage or the landfill attendant.

C. No refuse may be deposited outside of the landfill gate or fences.

##### **8.12.050 – Violation – Penalty**

Violation of any section of this ordinance shall constitute an infraction punishable by a fine of \$250.00.


**Section 3:** Effective Date: This ordinance is effective upon its adaptation.


