

**CHARTER TOWNSHIP OF WHITE LAKE
ORDINANCE NO. 101
PAWNBROKERS ORDINANCE**

AN ORDINANCE TO AMEND THE PAWNBROKERS ORDINANCE.

Article III, Article V and Article VI of Ordinance No. 101, the Pawnbrokers Ordinance of the Township of White Lake are hereby amended to read as follows:

THE CHARTER TOWNSHIP OF WHITE LAKE ORDAINS:

ARTICLE I – AMENDMENT

ARTICLE III – PUBLIC ACT ADOPTED

The Charter Township of White Lake hereby adopts by reference, Act No. 273, of the Public Acts of 1917, as amended, being Sections 446.201 through 446.219 of the Michigan Compiled Laws ~~(hereinafter "the Act"), and Act No. 231 of the Public Acts of 1945, as amended, being Section 445.471 of the Michigan Compiled Laws.~~

~~In addition to the recording and reporting requirements found in the Act, specifically MCL 446.205, Dealer shall simultaneously submit the record of transaction electronically to the Police Chief or his designee, in a format that is capable of direct electronic entry into the White Lake Township Police Department's computerized system, or any system designated by the White Lake Township Police Department, as approved by the Police Chief or his designee, for identifying property coming into the possession of a dealer.~~

ARTICLE V – FEE, ANNUAL; BOND

The annual fee for a pawnbroker's license shall be ~~as established by the White Lake Township Fee Ordinance, Ordinance No. 122 by resolution of the Township Board,~~ and the initial annual fee shall be due and payable at the time of the filing of the application for a pawnbroker's license.

~~A bond in the amount of \$3,000.00, with at least 2 sureties, conditioned for the faithful performance of the duties and obligations pertaining to the conduct of the business and for the payment of all costs and damages incurred by any violation of the Act, shall be posted with the Township.~~

ARTICLE VI – INVESTIGATION OF APPLICATION; APPROVAL

Upon receipt of the application, the Township Clerk shall request a written report from the Township Chief of Police stating that no owner, co-partner, stockholder, manager or employee of the proposed licensee has been convicted of any crime involving moral turpitude or has a reputation of being a thief, associate of thieves, habitual drunkard, receiver of stolen property, gambler, or promoter of vice and immorality. The Chief of Police shall make a background investigation of the application in rendering this report.

In the event the application and subsequent report indicates that the issuance of the Pawnbroker License is in compliance with the Act, the Township shall grant the license.

The granting of a Pawnbroker License shall not be construed to excuse a licensee from complying with all other Township or State laws, including zoning and building codes.

This ordinance does not require licensure for an internet drop-off store that is in compliance with the Act and all other Township or State law provisions governing internet drop-off stores.

This ordinance does not require licensure for a person that is engaged in the sale, purchase, consignment, or trade of personal property or other valuable thing for himself or herself.

ARTICLE II - SEVERABILITY

The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by any court of competent jurisdiction, the remainder of the Ordinance shall remain in full force and effect.

ARTICLE III – REPEALER

All other ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

ARTICLE IV – REMAINING PROVISIONS

Except as expressly provided by this Ordinance Amendment, all other sections and subsections of the Pawnbroker Ordinance of the Charter Township of White Lake shall remain in full force and effect and, if necessary, renumbered and reformatted to give this Ordinance Amendment full force and effect.

ARTICLE V - EFFECTIVE DATE

The provisions of this Ordinance are hereby ordered to take effect upon subsequent adoption publication.

ARTICLE VI - ADOPTION

This Ordinance is hereby declared to have been adopted by the Township Board of the Charter Township of White Lake at a meeting duly called and held on the 18th day of March, 2014, and ordered to be given publication in the manner prescribed by law.
