**AN ORDINANCE AMENDING THE VILLAGE OF CHICAGO RIDGE FEE SCHEDULE
REGARDING AMBULANCE SERVICES**

WHEREAS, the Village of Chicago Ridge, Cook County, Illinois (the “*Village*”) is a home rule unit of local government pursuant to Article VII, Section 6, of the 1970 Illinois Constitution, and, except as limited by such section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the President and Board of Trustees of the Village of Chicago Ridge (the “Corporate Authorities”) may amend the Village Code from time to time to meet the changing needs of the Village; and

WHEREAS, the Corporate Authorities find it in the best interests of the health, safety and welfare of the Village and its citizens to amend the Village Fee Schedule regarding ambulance services.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chicago Ridge, Cook County, Illinois, as follows:

Section 1. That the above recitals are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Village of Chicago Ridge Fee Schedule is hereby amended by adding the underlined language and eliminating the stricken language as follows:

Section 3. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.


Section 4. All Ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.


