## ORDINANCE NUMBER 19-03-07

AN ORDINANCE AMENDING SECTION 2-44 (PRESIDENT'S EX OFFICIO MEMBERSHIP OF COMMITTEES; ENUMERATION OF COMMITTEES) OF DIVISION 2 (COMMITTEES) OF ARTICLE II (BOARD OF TRUSTEES) OF CHAPTER 2 (ADMINISTRATION) OF THE VILLAGE CODE IN THE VILLAGE OF CHICAGO RIDGE, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Chicago Ridge, Cook County, Illinois (the "Village") is a home rule unit of local government pursuant to Article VII, Section 6, of the 1970 Illinois Constitution, and, except as limited by such section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the President and Board of Trustees of the Village of Chicago Ridge (the "Corporate Authorities") may from time to time amend the text of the Village Code when it is determined to be in the best interests of the residents of the Village; and

WHEREAS, the Corporate Authorities wish to amend the Village Code provisions regarding standing committees; and

WHEREAS the Corporate Authorities find that the above-mentioned amendments are important to protecting the health, safety and welfare of Village residents; and

WHEREAS, the Corporate Authorities find it in the best interests of the Village to amend the Village Code provisions regarding standing committees to add a Fair Housing Committee as further provided below.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Chicago Ridge, Cook County, Illinois, as follows:

**Section 1.** That the above recital is found to be true and correct and is hereby incorporated herein and made a part hereof, as if fully set forth in its entirety.

**Section 2.** Section 2-44 (President's Ex Officio Membership of Committees; Enumeration of Committees) of Division 2 (Committees) of Article II (Board of Trustees) of Chapter 2 (Administration) the Village Code is hereby amended by adding the underlined language to provide as follows:

Sec. 2-44. - President's ex officio membership of committees; enumeration of committees.

The president of the village shall be ex officio a member of all committees. The standing committees to be appointed annually by the president shall be as follows:

- (1) Police/EMA;
- (2) Fire/traffic;
- (3) Public works/buildings and grounds;
- (4) Finance/insurance/youth service bureau;
- (5) Health/licensing/administration;
- (6) Building/planning and zoning/ordinances/cable TV; and
- (7) Fair Housing

**Section 3.** Those provisions of the Village Code that have not been expressly amended herein shall remain in full force and effect.

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5.** All Ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6**. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
