**ORDINANCE NO. 2020-011**

AMENDMENT TO THE CODE ORDINANCES DATED January 15, 2020

AN AMENDMENT TO ST. LANDRY PARISH CODE OF ORDINANCES ADDING SECTION 10.6 (E) EXEMPTIONS FOR CERTAIN FARM STRUCTURES OF THE BUILDING PERMITS ORDINANCE, TO COMPLY WITH THE LOUISIANA TITLE 55 PUBLIC SAFETY PART VI. UNIFORM CONSTRUCTION CODE ENFORCEMENT

WHEREAS, Louisiana Title 55 Public Safety Part VI of the Uniform Construction Code Enforcement provides for certain exemptions for Farm Structures, and

WHEREAS, the St. Landry Parish Council in compliance with Louisiana State Law hereby adopts those exemptions for Farm Structure as defined in the definition of Farm Structures as herein provided, and

WHEREAS, for the purpose of this Ordinance the definition of a farm is a place where crops are grown or animals are raised for food and other products, and

WHEREAS, the definition for Farm Structures is hereby describe as; a structure which is constructed on a farm, other than a residence or structure attached to it, for use on the farm including , but not limited to barns, shed, greenhouses and poultry houses, and

WHEREAS, a structure which is constructed on a farm, other than a residence or structure attached to it, for use on the farm including , but not limited to barns, shed, greenhouses and poultry houses, and

WHEREAS, this ordinance shall be made retroactive as of January 15, 2020, and

WHEREAS, all permit fees and inspection fees assessed and collected from applicants for greenhouses since January 15, 2020, be refunded to the applicants.

NOW THEREFORE, BE IT ORDAINED BY THE ST. LANDRY PARISH, does hereby adopt Louisiana Title 55 Public Safety Part VI of the Uniform Construction Code Enforcement which provides for exemptions for certain Farm Structures said Farm Structures are defined as; farm structures which is constructed on a farm, other than a residence or structure attached to it, for use on the farm including, but not limited to barns, shed, greenhouses and poultry houses,

BE IT FURNTER ORDAINED that the definition for Farms and Farm Structures by adopted.

BE IT FRUTHER ORDAINED, that this ordinance shall be made retroactive as of January 15, 2020.

BE IT FURTHER ORDAINED, all permit fees and inspection fees assessed and collected from applicants for greenhouses since January 15, 2020 shall be refunded.


