AN ORDINANCE TO ABOLISH ST. LANDRY PARISH WATERWORKS DISTRICT NUMBER 2 (PRAIRIE RHONDE/GARLAND/WHITEVILLE).

WHEREAS, there is the St. Landry Parish Waterworks District number 2 (Prairie Rhonde/Garland/Whiteville) and the St. Landry Parish Waterworks District number 2 (Rural).

WHEREAS, this Ordinance abolishes the St. Landry Parish Waterworks District number 2 (Prairie Rhonde/Garland/Whiteville), but does not abolish the St. Landry Parish Waterworks District number 2 (Rural).

BE IT ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that:

St. Landry Parish Waterworks District number 2 (Prairie Rhonde/Garland/Whiteville) is hereby abolished, effective July 1, 2019, and St. Landry Parish Waterworks District Number 2 (Rural) shall continue to exist.


