ORDINANCE NO. 2019-006

AN ORDINANCE TO AMEND ST. LANDRY PARISH ORDINANCE CHAPTER 36, ARTICLE X – FOUR-WAY INTERSECTIONS, SECTION 36-220 so that the intersection of Grant Road and Helen Garland is no longer designated as a four-way intersection, and the stop sign at the Intersection of Grant Road and Helen Garland will therefore be removed.

WHEREAS, St. Landry Parish Ordinance Chapter 36, Article X, Section 36-220 designates the intersection of Grant Road and Helen Garland as a four-way intersection.

WHEREAS, this Ordinance amends St. Landry Parish Ordinance Chapter 36, Article X, Section 36-220 so that the intersection of Grant Road and Helen Garland is no longer designated as a four-way intersection.

WHEREAS, the stop sign at the intersection of Grant Road and Helen Garland must be removed once this Ordinance is enacted, because the intersection of Grant Road and Helen Garland will no longer be designated as a four-way intersection.

BE IT ORDAINED BY THE COUNCIL FOR ST. LANDRY PARISH GOVERNMENT that Chapter 36, Article X-Four-Way Intersection, Section 36-220 is hereby amended as follows:

The following roads are hereby designated as four-way intersections:

- (1) The intersection of Amaretto Drive and Shiraz Drive.
- (2) The intersection of North St. Mary Lane and Dexter Lane.
- (3) The intersection of Fort Hamilton Drive and Cypress Drive/Meadow Circle.

This Ordinance having been introduced on the 15th, day of May, 2019, notice of Public Hearing having been published, said public hearing having been held, the title having been read, and the Ordinance considered, a record vote was taken and the following results were had:
