

AN ORDINANCE PROVIDING FOR DESIGNATION OF NO PARKING AREAS IN THE CITY, FOR PREVENTION OF NONDEDICATED USE OF A STREET, AND PUNISHMENT FOR THE VIOLATION THEREOF AND FOR OTHER PURPOSES.

WHEREAS, It is in the best interest of the citizens of the City of Bryant that rules and regulations for no parking be established and that street use be regulated:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRYANT, ARKANSAS:

SECTION ONE: Authority is hereby given the City Council, the Street Department, and the Mayor, to designate no parking areas within the City of Bryant.

SECTION TWO: Said no parking areas are to be plainly marked by installation of a sign which shall plainly designate said area as a no parking zone.

SECTION THREE: It shall be unlawful for any person owning or operating a motor vehicle to park or leave such vehicle within an area designated as a no parking zone whether said no parking zone is on a city street or located off road.

SECTION FOUR: It shall be unlawful for any person owning or operating a motor vehicle to park within 15 feet in any direction from a fire plug (hydrant) located within the City of Bryant. Notice by sign is not necessary for said parking to be a violation. The prohibited area includes both on street and off street use. It shall also be unlawful for any person to block or hinder any approach to a fire plug (hydrant) in any manner within the City of Bryant.

SECTION FIVE: It shall be unlawful for any person to make use of any designated street within the City of Bryant for any uses, including but not limited to burning of trash or leaves, garbage or trash disposal, or parking of abandoned vehicles, or storage of any item.

SECTION SIX: Any unlawful action in violation of this ordinance shall be a misdemeanor and punishable as follows:

(a) Illegal Parking; a fine of not less than \$5.00 nor more than \$25.00 with no court costs associated therewith if paid within 15 days. After 15 days a warrant shall be issued through municipal Court and court costs shall then attach.

(b) Parking o close to a fire plug: fine of not less than \$10.00 nor more than \$50.00 with no court costs associated therewith if paid within 15 days. After 15 days a warrant shall be issued through municipal court and court costs shall then attach.

(c) Hindering approach to a fire plug: A fine of not less than \$30.00 nor more than \$100.00 . Court costs shall be associated with this offense at all levels.

(d) Non Designated use of a Street: A fine of not less than \$25.00 nor more than \$100.00. Court costs shall be associated with this offense at all levels.

SECTION SEVEN: It being necessary to protect the health and welfare of the citizens of the City of Bryant, this ordinance shall have full force and effect from and after its date of passage.
