ORDINANCE AMENDING THE ST. TAMMANY PARISH UNIFIED DEVELOPMENT CODE, SECTION 130-5 - DEFINITIONS- TO INCLUDE ADDITIONAL LANGUAGE IN THE DEFINITION OF A FUNERAL HOME.

WHEREAS, a Funeral Home is defined as a dwelling or other structure used and occupied by a professional licensed mortician for burial preparation and funeral services; and

WHEREAS, some funeral homes also provide the services of a crematorium; and

WHEREAS, crematorium are not compatible with the uses in certain commercially zoned districts; and

WHEREAS, to promote the health, safety and welfare of citizens, the St. Tammany Parish Government considers it necessary to amend the St. Tammany Parish Code of Ordinances and its Unified Development Code to amend the definition of a Funeral Home to exclude crematoriums.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it amends the St. Tammany Parish Chapter 130 Unified Development Code, Section 130-5 to amend the definition of a Funeral Home as follows:

Funeral home means a dwelling or other structure used and occupied by a professional licensed mortician for burial preparation and funeral services, excluding crematoriums.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.




