## **ORDINANCE NO. 2771**

AN ORDINANCE AUTHORIZING THE PLACEMENT OF A LIEN FOR UNPAID SEWER BILL ON THE PROPERTY LOCATED AT 198 MARGARET STREET, HOLTS SUMMIT, MISSOURI.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HOLTS SUMMIT, MISSOURI, AS FOLLOWS:

Section 1. Authorizing Lien. In accordance with Section 250.234 RSMo and City Code Section 46.120, The Board of Aldermen for the City of Holts Summit, Missouri hereby authorized the placement of a lien for unpaid sewer bills on the property located at 198 Margaret Street, Holts Summit, Missouri, in the amount of \$393.08. The Board of Aldermen of the City of Holts Summit, Missouri, hereby authorizes Mayor Landon Oxley to sign said lien attached as Exhibit A hereby approved, adopted, and made a part herein by reference as fully as if set out herein verbatim. Said Lien to be filed with the Callaway County Clerk's Office.

Section 2. Effective Date. The Board of Aldermen declares passage of this ordinance by conducting two reading during the same meeting to be necessary. This ordinance shall therefore be in full force and effect immediately upon its final passage and approval.
