ORDINANCE NO. 2716

AN ORDINANCE APPOINTING ANGELA SILVEY AS ALTERNATE MUNICIPAL COURT JUDGE AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH ANGELA SILVEY SAID SERVICES.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HOLTS SUMMIT, MISSOURI, AS FOLLOW:

Section 1. Appointing Alternate Municipal Court Judge. The Board of Aldermen of the City of Holts Summit, Missouri, hereby authorizes the Mayor to appoint Angela Silvey as Alternate Municipal Court Judge, beginning effect upon passage of this Ordinance.


Section 2. The compensation shall be \$115.00 (and no/100's) per hour for basic services, including minimum of two hours attending municipal court proceedings as needed, as described more particularly in the contract attached hereto and made a part of this Ordinance.



Section 4. Effective Date. This ordinance shall therefore be in full force and effect immediately upon its final passage.




