Section 1. The County of Westchester (the "County") is hereby authorized to terminate the current lease for the Glen Island Casino (a/k/a the Glen Island Harbour Club and hereinafter referred to as the "Glen Island Casino") and to enter into a new thirty (30) year lease with Homestyle Hospitality, LLC;

§2. In accordance with the terms of the lease, the County shall be paid minimum annual rent as follows: (i) Two Hundred Thousand Dollars (\$200,000) in years one through five of the lease, (ii) Two Hundred Ten Thousand Dollars (\$210,000) in years six through ten of the lease, (iii) Two Hundred Twenty Thousand Five Hundred Dollars (\$220,500) in years eleven through fifteen of the lease, (iv) Two Hundred Thirty-One Thousand Five Hundred Dollars (\$231,500) in years sixteen through twenty of the lease, (v) Two Hundred Forty-Three Thousand One Hundred Dollars (\$243,100) in years twenty-one through twenty-five of the lease, and (vi) Two Hundred Fifty-Five Thousand Two Hundred Fifty-Five (\$255,255) in years twenty-five through thirty of the lease. In addition, Homestyle Hospitality, LLC will pay to the County, as additional rent, a percentage annual gross receipts exceeding One Million (\$1,000,000) Dollars as follows: (i) six and one-half percent (6.5%) for years one through ten of the lease. (ii) seven percent (7%) for years eleven through fifteen of the lease, (iii) seven and one-half percent (7.5%) for years sixteen through twenty-five of the lease, and (iv) eight percent (8%) for years twenty-six through thirty of the lease. Furthermore, pursuant to the proposed lease, Homestyle Hospitality LLC, will spend a minimum of at least Two Million Eight Hundred Forty-Five Thousand Dollars (\$2,845,000) during years one through five of the lease on improvements to the Glen Island Casino, and a minimum of at least Two Million Two Hundred Fifty Thousand Dollars (\$2,250,000) during years six through ten of the lease. for a minimum total amount of improvements of Five Million Ninety-Five Thousand Dollars (\$5,095,000) during years one through ten of the lease. All improvements will be subject to the approval of the County and will be subject to further Environmental Review pursuant to SEQRA.
